APPOINTMENT OF A SERVICE PROVIDER FOR PROVISION OF SEWER WATER REMOVAL SERVICES AT DUBE AGRIZONE FOR THE PERIOD OF 36 MONTHS

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube Trade Port. Refer to www.dubetradeport.co.za for more information.

DTPC hereby invites proposals from competent companies for the removal of raw sewer water generated from 21kilolitre conservancy tank located at the Dube AgriZone 2, and discharge to a manhole within AgriZone 1 Water Treatment Works (which is 1km from the conservancy tank), on ad hoc basis.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- 20 points will be allocated to enterprises (or bidders) who are at least 51% Owned by Black people.

Compliance Requirement

- Bidders must submit a valid permit to deliver standard domestic effluent by road haulage issued by eThekweni Municipality.
