## **INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, expand, manage, and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

## **CONTEXT OF THIS PROCUREMENT**

To appoint a new BBBEE verification agency to verify and produce a SANParks BBBEE scorecard annually for the next 3 years

## **CONTRACT PERIOD**

The contract is for a period of three (3) years

## **SPECIFICATIONS/SCOPE OF WORK**

The appointed verification agency conducts the verification work as prescribed by legislation and guided by the BBBEE Commission on the detailed BBBEE Scorecard to provide SANParks with a signed verification certificate and to upload such verification certificate into the BBBEE Commission's verification portal/database. The verification agency issues one verification certificate for the entire SANParks for each audit year e.g. 2023/2024; 2024/2025; 2025/2026.

### **Verification Scorecard Utilised**

SANParks, as a State-Owned public entity, measures its economic empowerment activities under the Tourism Sector Score Card for demonstrating its good citizenship to its stakeholders.

### **Verification Methodology**

The contracted service provider conducts a series of verification activities as prescribed in the gazetted verification manual to assess, verify, and validate the supporting data that support the score on the SANParks BBBEE Scorecard. The contracted service provider provides the verification services utilising:

- B-BBEE Act No 53 of 2003, as amended in 2013;

- Codes of Good Practice issued in terms of Section 9(1) of the B-BBEE Act No 53 of 2003
- SANAS R47;
- Verification manual issued in terms of Section 10.1 of the Codes Series 000 statement 000 of the B-BBEE Code of Good Practice;

Directives and guidelines issued by the Department of Trade and Industry and the B-BBEE Commission;

- Any other legislation or regulation provided in the Codes but not limited to:
  - Employment Equity Act 55 of 1998
  - Skills Development Act 97 of 1998
  - Skills Development Amendment Act 31 of 2003

### **SANParks Deliverables**

Once SANParks has issued a purchase order for the specific year's verification, SANParks and the contractor arrange the time and venue of the opening meeting.

At the opening meeting, SANParks provides the following information for audit verification:

1. SANParks detailed scorecard for each measured pillar detailing the score of each of the sub-categories within the measured pillar;
2. The detailed calculations supporting the presented score for calculation verification;
3. The evidence file containing all information utilized in the calculation of the relevant score for sampling purposes as well as the audited Annual Performance Report inclusive of the audited financial statements;
4. The contact details for verification interviews;
5. Contact details and addresses of its geographical spread sites (available on its website).

### **Contractor's Responsibility**

The contracted service provider is responsible for carrying out a factual, thorough evaluation of the calculations and supporting data of SANParks B-BBEE scorecard in an effective managed manner delivering value for money.

The contracted service provider will be required to provide a detailed project plan with project deliverables, logistical plan, milestones, scope, schedules, cost and resources. The service provider will also have to provide a methodology outlining adequate management of the project.

The contracted service provider shall report to the SANParks contract manager and/or his/her delegate at least once a week from the signing of a contract until the end of the project and as and when each party requires. Where possible and appropriate, conference calls shall be held to facilitate such meetings.

It is envisaged that the SANParks will require an initial meeting with the successful service provider to agree on the project process.

The contracted service provider provides its verified scores of SANParks BBBEE certificate to the SANParks for review. Once both parties are in agreement concerning the scores and compliance with the gazettes and any BBBEE Commission ruling, the contracted service provider provides the signed verification certificate. The contracted service provider uploads the signed verification certificate in the verification certificate portal of the BBBEE Commission.

### **Management of Contract Service Delivery**

- All correspondence will be in writing.
- Issuing of purchase order for each audit utilising the price rates as set out in the SBD 3.
- SANParks and the contracted service provider have a commencement meeting to set project timelines for the verification and to manage the delivery of these timelines.
- The assigned contract manager, notified in writing to the contracted service provider at signing of the contract, measures the performance of the contractor in terms of total time to complete the verification exercise. SANParks manages

poor performance as per the general clauses section and applies penalties for poor performance by requiring the contracted service provider to correct the poor performance at its own cost.

- Where timelines cannot be adhered to or queries, the following protocol applies
