DETAIL SCOPE OF WORK

Data architect services are required to design/model the overall architecture of the Plant Data Universe describing all key components as well as all data connectors. It must also include a landscape that will enable the Generation display hierarchy and the capability to make the required data available within a unified customer self-service environment.

Data Architect services are required to render the following services:

- Conduct an in-depth analysis of the existing data warehousing environments and source systems to determine how data can be combined in a data model for effective business use
