- 4 Tenderers are requested to furnish the full registered name of the tendering company/supplier on the Form of Quotation and Form of Acceptance, Form B.
- 5 Tenderers are also required to sign each page of the Form of Quotation and Form of Acceptance, Form B, in the space provided at the bottom of each page.

2. OBJECTIVE

The objective of the report is to request for the approval of the Terms of Reference for the appointment of a service provider for the development of Business Impact Assessments and tailored solutions for the Department of Human Settlements. The selected service provider will be responsible for conducting thorough assessments of critical functions and operations within specific directorates, identifying potential risks and vulnerabilities, and formulating Business Continuity Plan (BCP) strategies to ensure uninterrupted service delivery. The focus of this phase is on Phase 1 BCP deliverables only.

3. BACKGROUND

The Department of Human Settlements (the Department/DHS) plays a crucial role in transforming communities through housing interventions. Disruptions to these services could have significant adverse impacts on communities and the City of Johannesburg's housing delivery objectives. In line with risk and compliance management responsibilities, the Department is mandated to develop a business continuity policy, strategy, and plan to ensure operational continuity in the face of potential business disruptions.

The Business Impact Assessments and solutions developed will enable the Department to continue providing services in the event of unpredictable business disruptions or catastrophic disasters. Additionally, these assessments and solutions will establish clear roles and responsibilities, communication protocols, stakeholder engagement guidelines, and comprehensive testing and training frameworks.

e) SCOPE OF WORK

The scope of work outlines the specific tasks and deliverables required from the selected service provider for the for the development of Business Impact Assessments and tailored solutions for the Department of Human Settlements.
