1. INTRODUCTION AND PURPOSE

The Rebecca Street Crematorium has 2 (two) JTE cremation machines/furnaces (BA1 and BA2) that must be properly and regularly maintained, and modifications/update of the software programme, to efficiently and effectively undertake a proper cremation.

2. BACKGROUND

The intention is to appoint a service provider for the maintenance of the two JTE cremation machines/furnaces, modifications/update of the software programme and training of cremation staff and monthly cost thereof.

- How was this bid/project identified?

The Rebecca Street Crematorium is owned and managed by the city, which performs private cremations, a chapel service, and public cremations 363 days a year at times required by the bereaved (dependent on religious and /or cultural beliefs). Furthermore, due to certain religious requirements, deceased mortals must be cremated within 12–24-hour period. This then makes it essential that the machines/furnaces be maintained as a matter of urgency.

This objective is aligned with the City's Strategic Objectives - Sustainable City: A City that delivers excellent services and protects the environment.

The objective to appoint a service provider that can undertake the maintenance of the cremation machines/furnaces, modify/update the software programme and train cremation staff.

4. DELIVERABLES

a. The Proposal

- i) The supply of skilled labour, inclusive of travelling, to perform the following activities on a once per month basis
- ii) Adjust doors to seal adequately and check door hydraulics on both cremators
 - The inspection of the cremators (JTE BA1 and JTE BA2)
 - Check on operations and provide advise where necessary
 - Listen and take note of operator problems with the cremators (JTE BA1 and JTE BA2)
 - Inspect the internal refractory, hearth, side walls and roof
 - Make combustion system adjustments where necessary. Check operating gas pressure is at 25mb and adjust if required
 - Inspect ancillary equipment, cardboard roller stock, lift tables, clean out tools, cremulator
 - Check for hydraulic leaks from around the power pack or pipe connections and joints in the piping from pack to cylinders. Tighten if necessary
 - Provide CoT with a comprehensive inspection report, after every inspection
 - Install updates to the hmi programming when available
 - Provide a twenty-four (24) hour breakdown service as may be required by CoT upon request from CoT
 - Assist with technical and safety information as and when required and as prescribed on the Operating and Maintenance Manual
 - Supply and install parts as and when required and upon obtaining formal approval from CoT.

Any service provided to the CoT that falls outside of the scope of work shall be dealt with as follows:

- CoT shall make a formal request as may be necessary to the Service Provider and such a request shall be accepted by the Service Provider
- CoT reserves the right to allocate extra work which shall be in line the Service Level Agreement.

 - Bidders are required to submit supporting documents for their bids to claim the specific goal points.
 - Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.
 - Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

Such additional documentation and specialist work should be clearly indicated in the submission.

The Bill of Quantities are provided in unit measures and only quantities of work finally accepted and certified for payment shall be used to determine payment to the service provider. Work shall be valued at the prices tendered.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the tender.
