1. INTRODUCTION AND BACKGROUND

- 1.1. SASSETA is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's license has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.
- 1.2. The SASSETA is currently administering time and attendance of learners manually for projects that are dispersed nationally. This request is to assist to automate the process.

2. PURPOSE OF THE REQUEST FOR INFORMATION AND SPECIFICATION

- 2.1. The purpose of the Request for Information (RFI) is to solicit information on an end-to-end time and attendance management solution/s for learners available in the market that also has stipends disbursement functionalities to enable payments.
- 2.2. The service provider to submit a proposal/s on an existing time and attendance management solution/s that tracks learner attendance. The system is required to centrally generate reports and prepare payment files.

- 3.1. Bidders to propose a pricing structure / model based on a former / current client indicating all the variables (i.e. fixed cost, variable cost, licensing cost, etc.)
