


Maintenance shutdown at (PEMPT) Manganese Terminal

SCOPE OF WORK: Structural repairs for C-REC AND 6C

Introduction:

Port Elizabeth Multi-Purpose Terminal (PEMPT's) core business is to import and export dry bulk cargo manganese ore. This is accomplished with terminal infrastructure such as rail wagon tippler, feeders, conveyor belts, storage facilities and ship-loaders and a network of machine mobile equipment such as excavator and bulldozer. Shutdowns is the only time we perform an intense structural maintenance on the machine to keep the plant integrity and increase the machine reliability.

1. Scope of work:

1.1. A Reclaimer

1.1.1. Bucket wheel hopper

- replace all hopper liners
- replace all hopper steel skirting
- replace all hopper rubber skirting
- replace hopper base plate and mounting bolts .
- replace all damaged to the hopper side plates.
- Replace all hopper mounting bolts

1.1.2. Bucket wheel

- Manufacture and replace all Eyebrow liners.
- Replace all cell liners in Bucket wheel.
- Replace all face liners on Bucket wheel face.
