## **1. BACKGROUND**

With the addition of the newly appointed 2000 additional members a need was identified to train more instructors to deal with the demand.

The aim of this training is to ensure more trainers are available to train members tactically with firearms and maintenance shooting as required by legislation. The training is to be conducted in Tshwane (if not possible other areas will be accommodated), City of Tshwane, Tshwane Metropolitan Police Department and external stakeholders will form part of the Training. TMPD training college will be utilised for this training and TMPD shooting range if it is not available the service provider will provide facilities. A training service provider is needed to facilitate and demonstrate the principles of the handle and use of firearms as per specified registered unit standards. The service provider needs to assess and moderate members on the course in line with the registered unit standards. The provider must be an established/ accredited body and provide proof and certificate of accreditation at PFTC. Upon completion of the course, successful members must be registered at PFTC AND SASSETTA by the service provider.

## **2. PROJECT SCOPE**

The provider must be an established/ accredited body and provide proof and certificate of accreditation at PFTC ( Professional Firearm Training Council).

Service provider must be an experienced training service provider and provide appointment letter and reference letter of previous similar work undertaken.

Facilitation of a Maximum 6-week for 15 learners for the course on an as and when required basis to be facilitated at Akasia Shooting Range.

Registered learning material or appropriate hand-outs to be provided to each learner (All learning material must be registered and accredited by PFTC (Professional Firearms Training Council))

PowerPoint slides of the presentation to be made available to the learners.

Appropriate registered assessment Shooting exercises during the course to be utilized to monitor the learning process. Final assessment for competency and registration to PFTC and SASSETA. Ammunition and Shooting range will be provided for all exercise and assessments by Tshwane Metropolitan Police Department: Academy

Certificates of competence must be issued by the service provider and registration of members to the Professional Firearms Training Council (PFTC) and Safety and Security, Sector Education & Training Authority (SASSETA) within a reasonable time not exceeding 3 Calendar Months.

Bidders are required to submit supporting documents for their bids to claim the specific goal points.

Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 90 for price only and zero (0) points out of 10 for specific goals.

The City of Tshwane shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

Should the city exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be able to deliver on the price, if a bidder confirms that they cannot, the bidder will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder scoring the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
