# TERMS OF REFERENCE TO PROCURE THE SANITIZERS FOR THE REGIONS

The Independent Development Trust (IDT) is a Schedule 2 Public Entity governed by a Deed of Trust, the Public Finance Management Act (Act No. 1 of 1999), as amended by Act of No. 29 of 1999 (PFMA) and relevant legislative frameworks.

The IDT is a programme management and implementation agency of the Department of Public Works and Infrastructure.

The IDT is implementing the Expanded Public Works Programme Non-State Sector on behalf of the Department of Public Works and Infrastructure (DPWI). In preparation to commence the implementation of the programme for 2021/2022 financial year, the IDT has to procure the sanitizers for the participants.

The objective is to procure a service provider for each region to supply the required quantities of sanitizers.

1. **Compulsory returnable documents** that must be submitted with the response for this bid are the following:
  - a) National Treasury Central Supplier Database number MAAA\_\_\_\_\_.
  - b) Unique SARS Tax Compliance Pin.
