1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

- a) Either the 90/10 or 80/20 preference point system will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim specific goals with the tender, will be interpreted to mean that preference specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender.

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

APPOINTMENT OF A PANEL OF PROFESSIONAL RESOURCE TEAMS FOR FREE STATE HUMAN SETTLEMENTS TO BE APPOINTED ON “AS AND WHEN REQUIRED” FOR: TOWN PLANNING SERVICES FOR DEPARTMENTAL PROJECTS FOR PERIOD OF 36 MONTHS.



1. INTRODUCTION AND BACKGROUND

Free State Human Settlements is the official implementing agent of sustainable human settlements in the province through government-wide human settlements policies and programmes. The Free State Human Settlements is funding several projects in various municipalities through the Human Settlements Development Grant (HSDG) and Informal Settlements Upgrading Partnership Grant (ISUPG). The department promotes sustainable communities by amongst others, making well-located land available for the development of human settlements, upgrading of informal settlements either through in-situ upgrading or relocation to a new development, establishment of new mixed development areas, and building of housing top structures for the qualifying beneficiaries.

The department is committed in its cause to address the problems that are related to tenure rights and the provision of proper services for the people of the Free State, especially those living in the informal settlement areas as well as the other income groups.

As part of the Upgrading of Informal Settlements Programme and creating an enabling environment for municipalities, in order to address human settlements challenges, the department has in collaboration with municipalities, identified settlements that need attention, and these were drawn from the existing Provincial Informal Settlements Register which is reviewed and updated on an ongoing basis. There is also the provincial informal settlements strategy compiled as a roadmap for implementation of the informal settlements upgrading programme. This panel will be key in the implementation of the said strategy.

There is also the Multi Year Development Plan, which identifies areas in municipalities that need to be developed as part of forward planning, to cater for the growing need for serviced sites as well as to circumvent the evolvment of informal settlements. All of these plans and strategies have time period attached to them and therefore it becomes crucial that the department is ready at all material times to implement the content contained in the said documents hence the request.

2. OBJECTIVE OF THE PANEL

The objectives of these panel of the Professional Resource Team, is to enable the department to address the municipal housing needs and to upgrade the informal settlements in the identified municipalities and to ensure security of tenure to the households living in these settlements in a shortest possible time.

To achieve the above, the services of suitably qualified Professional Resource Teams is sought to undertake township establishments as well as other land development processes in line with the approved municipal Spatial Development Frameworks, Housing Development Chapters, and Integrated Development Plans.

3. SCOPE OF WORK

3.1 FOR TOWN PLANNING

The appointed service providers are expected to undertake the following services which include (but are not limited to) the following in ensuring the approval and proclamation of the townships.



- a. To submit a township establishment application to the various Municipalities in which they would have been appointed, in terms of SPLUMA and Municipal Planning By-laws, as well as approval thereof.
- b. To prepare submission(s) and solicit comments from various departments and SOEs regarding the application(s).
- c. To ensure survey, pegging and approval of the layout plans by the surveyor general.
- d. The appointed service providers must take care of all the necessary administrative functions of the application, including, but not limited to: meetings and stakeholder engagements, presentations as approved and agreed to with the Department of Human Settlements.
- e. To ensure that the townships are approved, general plans approved and amended where applicable, registered by the Deeds Registry and proclaimed.

3.2 FOR SUBDIVISION AND REZONING SERVICE

- a. To undertake the subdivision and rezoning application processes or any other land use rights applications required in order to establish a sustainable human settlement development.
- b. Create erven which suit the purpose for which they are intended, in this case residential erven.
- c. Attain the highest residential densities in line with the concerned municipalities' bylaws in order to accommodate the existing households.
- d. Obtain approved town planning application from the relevant authority(ies), Municipal Planning Tribunal (MPT) Approval and General Plans (GPs) approval from the Surveyor General (SG)
- e. Facilitate the development of sustainable human settlements and expedite the process of obtaining a town planning approval.

The following studies should be conducted by the service providers as part of a complete application. These are amongst others as listed below:

- a. Traffic Impact Assessment
- b. Engineering Services Report including electrical report
- c. Contour studies
- d. Geotechnical studies
- e. Environmental Impact Assessment Report as well as a Topographical Plan. **(including any other specialized studies that might be triggered by the EIA, such as hydrological study, wetland delineation study, WULA application etc.)**

Further, the following package of plans should be referred to (the list is not exhaustive):

- a. Municipal Spatial Development Framework
- b. Municipal Housing sector plan
- c. Enumeration, Rapid Assessment and Resettlement Plan reports
- d. Area based Town Planning Scheme/Municipal Land Use Management Schemes
- e. Municipal Housing needs as registered on NHNR

4. DELIVERABLES AND OUTPUTS FOR TOWN PLANNING

In accordance with framework for ISUPG; the relevant standards and procedures for professional practice and the contracted scope of work, the professional service providers will submit and make oral presentation on the following outputs and ensure that the deliverables are achieved as outlined in an implementation plan to be agreed upon with the client.



- a. Township approval and conditions of establishment from the Municipality.
- b. Approved General Plan from the Surveyor General.
- c. Amendment of the General Plan and rezoning certificate.
- d. Approval, and opening of a township register by the Deeds Registry as well as proclamation of a township.

Further, the professional service provider will submit the work as outlined on the scope of work and in a format that is possible to calibrate and manipulate with other GIS related tools and CAD software (DWG/DXF). Hard copies of all reports are also required.

5. TEAM COMPOSITION FOR TOWN PLANNING SERVICES

The Professional Resource Team for Township Planning projects should be composed of the following list of professionally registered professionals in order to show capacity to successfully implement the project in its entirety.

- Town and Regional Planner
- Land Surveyor
- Civil Engineer
- Environmental Scientist
- Conveyancer

6. COSTS

The allocation of work and/or projects and the value of work to be given to the appointed service provider(s) will be determined by the Accounting Officer.

7. VERIFICATION OF DOCUMENTS

It is advisable for the respondents to verify their page numbering to ensure that there are no missing pages. No liability will be accepted by the department regarding anything arising on the issue of missing pages.

8. EVALUATION PROCESS

The evaluation process comprises the following phases:

NB: Tenders will be evaluated in 4 phases:

- Phase I: Administrative Compliance**
- Phase II: Mandatory Requirements**
- Phase III: Evaluation Criteria – Functionality**
- Phase IV: Allocation of work**

8.1 PHASE I: ADMINISTRATIVE COMPLIANCE

- a. Company registration certificate.
- b. The following SBD forms must be completed and signed accordingly by duly authorized representative; SBD 1, SBD 4 and SBD 6.1



8.2 PHASE II: MANDATORY REQUIREMENTS

a. CSD registration.

The Bidders must be registered as a service provider on the Central Supplier Database (CSD). If you are not registered proceed to complete the registration of your company prior to submitting your bid. Refer to <https://secure.csd.gov.za/> to register your company. Ensure that all documentation on the database is updated and valid.

b. SARS Tax Pin Status.

It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations at the point of awarding.

The Tax Compliance status requirements are also applicable to foreign bidders/individuals who wish to submit bids.

Consortia/Joint Ventures/Sub-contractors:

Where Consortia/Joint Ventures/Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

In bids where consortia/joint ventures / sub-contractors are involved, each party must submit a separate tax pin/CSD number.

OTHER MANDATORY REQUIREMENTS

a. **Mandatory Requirements for Town Planning Services:**

Lead Town Planners must be registered as a professional Town Planner in line with the South African Council for Planners (SACPLAN). **Certified registration certificate with SACPLAN should be submitted.**

b. A Joint Venture agreement in case of a Joint Venture.

c. The tender or any of its directors are not listed on the Register of Tenderer Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004.

Bidders will be disqualified for failure to produce the above-mentioned certificates.

NON-MANDATORY REQUIREMENTS

a. SANAS approved B-BBEE certificate and in case of a Joint Venture a combined certificate should be submitted.

All the above certificates must be valid and not expired or inactive at the time of submission of the tender.



8.3 PHASE III: EVALUATION CRITERIA – FUNCTIONALITY

Bidders must achieve a minimum of 70 points of the functionality points to be eligible to be on the database. Any proposal not meeting the minimum score of **70 points** on the technical functionality at the time of bid closing date will be disqualified.

Functionality will be evaluated on the basis of the responses on the Functionality Criteria and supporting documentation.

8.4 PHASE IV: ALLOCATION OF WORK

The allocation of work and/or projects and the value of work to be given to appointed service provider(s) will be determined by the Accounting Officer.

Note: The Free State Department of Human Settlements reserves the right and sole discretion to appoint more than one bidder (s) to implement projects based on the work/projects that are available. Inclusion of Service Providers on the panel does not automatically lead to an appointment

9. VERIFICATION OF DOCUMENTS

Respondents should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by the department in regard to anything arising from the fact that pages are missing or duplicated.

10. SUBMISSION OF BID

11. OFFICIALS PROHIBITED FROM SUBMITTING BIDS

In accordance with Treasury Instruction Note 17 of 2012, an employee of the State/Government or a Public Entity may not have a business interest in any entity conducting business with the Provincial Government.

The Provincial Government may not award any tender or enter into any contract with an employee of the State/Government or a provincial public entity contrary to Treasury Instruction Note 17 of 2012.

All bids received contrary to Treasury Instruction Note 17 of 2012 shall be disqualified.

For the definition of “business interest”, “employee” and “entity”, refer to par. 5 of Treasury Instruction Note 17 of 2012.



12. TERMINATION RIGHTS

An agreement can be terminated by a participant on grounds of poor service delivery or any other breach by the bidder.

Free State Human Settlements will be in a position to terminate an agreement without honouring the outstanding months where after following the prescribed remedial process stipulated in the agreement between the bidder and the Free State Human Settlements, it is proven that the bidder failed to remedy the poor provision of service.

13. AGREEMENTS

The Service Provider(s) will be expected to sign a framework agreement with the Free State Provincial Treasury on behalf of each participating Department. The Service Level Agreement will be subject to the bid documents, including the General Conditions of Contract (GCC) and Special Conditions of Contract (SCC).

14. OFFICIALS PROHIBITED FROM SUBMITTING BIDS

In accordance with Treasury Instruction Note 17 of 2012, an employee of the State/Government or a Public Entity may not have a business interest in any entity conducting business with the Provincial Government.

The Provincial Government may not award any tender or enter into any contract with an employee of the State/Government or a provincial public entity contrary to Treasury Instruction Note 17 of 2012.

All bids received contrary to Treasury Instruction Note 17 of 2012 shall be disqualified.

For the definition of “business interest”, “employee” and “entity”, refer to par. 5 of Treasury Instruction Note 17 of 2012.



15. SETTLEMENT OF DISPUTES

Notwithstanding clause 27 of the GCC, mediation proceedings will not be applicable to this contract

ACCEPTANCE OF THE TERMS OF REFERENCE AND GENERAL CONDITIONS OF CONTRACT

Failure to accept the Terms of Reference and the General Conditions of Contract or any part thereof, may result in the bid not being considered. Bidders may not amend any of the Special Conditions or include their own conditions; as such amendments or inclusions will result in disqualification of the bid.

14. Payment	<p>16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.</p> <p>16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.</p> <p>16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.</p> <p>16.4 Payment will be made in Rand unless otherwise stipulated in SCC.</p>



17. Prices	17.1	Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
18. Contract amendments	18.1	No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
19. Assignment	19.1	The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
20. Subcontracts	20.1	The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
21. Delays in the supplier's performance	21.1	Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
	21.2	If at any time during performance of the contract, the supplier or its sub bidder(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
	21.3	No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
	21.4	The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
	21.5	Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

		27.4	Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
		27.5	Notwithstanding any reference to mediation and/or court proceedings herein, (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and (b) the purchaser shall pay the supplier any monies due the supplier.
28. Limitation liability	of	28.1	Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language		29.1	The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law		30.1	The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices		31.1	Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
		31.2	The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties		32.1	A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
		32.2	A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
		32.3	No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.



33. National Industrial Participation (NIP) Programme	33.1	The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
34. Prohibition of Restrictive practices	34.1	In terms of Section 4 (1) (b) (iii) of the Competition Act No.89 of 1998, as amended, and agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is /are or a contractor (s) was/were involved in collusive bidding (or bid rigging).
	34.2	If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has/have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No.89 of 1998.
	34.3	If a bidder(s) or contractor(s), has/have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and/or terminate the contract in whole or part, and/or restrict the bidder(s) or contractor (s) from conducting business with the public sector for a period not exceeding ten (10) years and/or claim damages from the bidder(s) or contractor(s) concerned.
