INTRODUCTION TO THE NRF
The National Research Foundation Act, Act 23 of 1998, establishes the National Research Foundation ("NRF") as the juristic person that makes this bid invitation and will contract with the awarded bidder. The Public Finance Management Act classifies the organisation as a Schedule 3A Public Entity.
CONTEXT OF THIS PROCUREMENT
NRF-SAEON requires office facilities for the permanent staff members of the Kimberley Tri-Biome (KIMTRI) Landscape of the Expanded Freshwater and Terrestrial Environmental Observation Network (EFTEON) based in Kimberley.
A site visit will be arranged and undertaken to confirm the facilities offered by potential suppliers
CONTRACT PERIOD
4-year office space rental contract (excluding water, electricity, internet services, and security in the form of an alarm system) to start mid-February 2026
NB – Rental rate escalation needs to be included on an annual basis for the duration of the contract
DESCRIPTION OF GOODS/DETAILED SPECIFICATION
<p>The purpose of the project is to appoint a service provider(s) who will be able to provide a rental space to be used as office facilities needed by the Kimberley Tri-Biome (KIMTRI) Landscape of the Expanded Freshwater and Terrestrial Environmental Observation Network (EFTEON). These office facilities will be used on a daily basis by the permanent staff members of the EFTEON KIMTRI Landscape for administrative purposes, and should be within a 5 km distance from the SAEON-Arid Lands Node offices (SANParks, Kimberley, S28°46'18", E24°45'03"), and the Sol Plaatje University (S28°44'53", E24°45'55"). KIMTRI staff would ideally like to move into the premises mid-January 2026.</p> <p>Office Facilities</p> <p>The EFTEON KIMTRI Landscape will need a rental space to be used as office facilities for the permanent staff complement of EFTEON based in Kimberley.</p> <ul style="list-style-type: none"> • One individual office (size range 12-20 m² - e.g., 4 m x 3 m to 4 m x 5 m) with windows and electrical connection point • 2 shared offices (16-30 m² each e.g. 4 m x 4 m to 6 m x 5 m), with space for 2 desks each and electrical connections. Or 4 individual offices (~9-12 m² each) with windows and electrical connections • Shared office space for open plan office – (25-40 m²), with windows and electrical connection • Kitchen facilities, including Sink, counter space and electrical connections • Bathroom facilities, including at a minimum a toilet, and wash basin <p>We currently have one Landscape Scientist, one Instrumentation Technician, and one Biodiversity Technician, and we expect to add one Socio-Ecological Systems (SES) Technician in the next financial year.</p> <p>For this, we need a space with at least one individual office (9–16 m²) for the scientist, and two shared</p>

offices (12–16 m²) for the technicians with ample space for two desks. However, a space with four individual rooms/offices (9–12 m²) would be more preferable, since technicians have different meetings at different times, and would need some privacy for these to take place comfortably.

In addition to the main office spaces, EFTEON will require space for visiting students, interns, postdocs, and researchers. This would be most suitable as an open plan shared space with 3–5 work stations (~25–40 m²). If necessary, these shared offices could be made available to other short-term visitors to the KIMTRI Landscape.

Laboratory Facilities

Apart from office space, the potential rental property should allow a space to be implemented as a laboratory, this will entail the installation of non-fixed tables or work benches.

Soil and Vegetation Processing Lab

This space will be used for the processing of dirty/raw materials such as sieving and weighing soil, and the processing of vegetation samples. This lab space would require good lighting, good ventilation, and basins with a soil trap for the preparation and processing of materials. If no soil trap is currently installed, EFTEON will do so at a later stage.

This lab space needs to have enough space and electrical connection to contain a drying oven, and would need cupboards, or shelving for the storage of equipment. The dirty lab space should be approximately 20 m², and ~8 running meters of work surface.

Weighing and Microscopy Lab

This lab space would be used for the preparation of reagents or specimens that would require a moderate level of cleanliness (i.e. not the dirt produced during sieving and soil preparation processes). This laboratory would be used for the preparation of samples, the weighing of specimens, simple microscopy and other similar activities.

This lab space will need sufficient electrical connections, and a working water connection with a basin. Moreover, this space would house refrigeration (4°C and -18°C). This lab space would need to be sufficiently ventilated and/or temperature controlled (i.e. air conditioning). Similar to the soil and vegetation processing lab, the weighing and microscopy lab would need good lighting. It will need to be approximately 20 m² in size and to have 6–8 running meters of work surface that is wear and spill resistant. Shelves and cupboards will be needed for storage of equipment and reagents (if these are not available non-fixed work benches/ tables will be installed).

Instrumentation Lab

This laboratory may be combined with the clean lab and will be needed for the preparation and calibration of field instrumentation. This laboratory will require 3-5 running meters of work surface and electrical connections and water connections for the hydrological instrumentation.

Storage Facilities

The EFTEON site will require safe storage for instrumentation (that can be locked up securely) and space for the storage of field equipment such as quadrants, tools (spades, clippers, bush cutters, tape measures et cetera). ~20 m²

Vehicle Parking Space

The EFTEON KIMTRI Landscape will have at least 2 vehicles which will need secure, covered parking, a car port would be appropriate and parking access for EFTEON staff (4 spaces) .

Electricity, water and other services

The facilities must have existing mains electricity and water reticulation with suitable hygienic waste disposal. Reliable cell phone signal is essential. Good internet access would be an advantage.

Scientific Engagement: As SAEON/EFTEON is a scientific organisation suitable space scientific engagement would be a distinct advantage.

Maintenance and General Upkeep
