1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act (MHSA), No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on Mine Health and Safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

The mining sector is associated with high levels of tuberculosis (TB). Although the TB incidence rate has been consistently decreasing since 2016, it remains high particularly in the gold sector and among employees living with HIV. Pulmonary TB cases also remain high. The high prevalence of silicosis among mine workers as a result of prolonged exposure to high silica levels in mine shafts makes them vulnerable to TB. Compounding the challenge is the high rate of HIV and TB, unfavourable working conditions in the mines (including poor ventilation), and poor living conditions which increases the mine workers' risk of contracting communicable diseases.

At the MHS Summit held in November 2011 the principals of the tripartite stakeholders (organised labour, employers and the state) made commitments to undertake a project that will review and revise the current TB audit tool to include HIV/AIDS, Silicosis and other occupational lung diseases common in the SAMI and promote implementation thereof. The MHSC has since reviewed the existing TB audit tool to add HIV and to align to the revised DMRE 164 reporting form for TB and HIV/AIDS.

The purpose of this tool is to provide guidance to SAMI users (e.g mines and DMPR officials) in auditing mines' integrated TB and HIV/AIDS, silicosis and occupational lung diseases programmes.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT

In an effort to contribute to the elimination of TB, HIV/AIDS, and commonly reported occupational lung diseases (OLDs) in the SAMI, the MHSC intends to appoint a service provider who will review and integrate the current TB and HIV audit tool into comprehensive tool that will be used to audit TB, HIV/AIDS, and commonly reported OLDs in the SAMI. In addition, the development of a strategy for the promotion and implementation of this revised audit tool will also be required. The tool to be developed needs to be digital and available for download and use by the SAMI.

2.2 CONTRACT PERIOD

The duration of this project is expected to be **18 Months**.

Note: The **15 months** will be allocated towards the project work.

The **3 months** will be allocated to MHSC administrative duties, such as project initiation, contracts, and project closeout.

2.3 DETAILED SPECIFICATIONS/SCOPE OF WORK

The service provider will be required to undertake the following as part of the scope of work:

- 2.3.1 Conduct a literature review on available audit tools pertaining to TB, HIV/AIDS, silicosis and other occupational lung diseases common in South Africa and internationally. The literature review should take into account various applicable guidelines and guidance notes in the SAMI, other industries and public sector on TB, HIV/AIDS, silicosis and occupational lung diseases. Other documents such as the declaration of TB in mines should be considered.
- 2.3.2 Review the current TB audit tool (and associated documentation) and make recommendation on the gaps.
- 2.3.3 Develop an integrated tool that will be used to audit TB, HIV/AIDS and OLDs in the SAMI. The tool must be electronic and downloadable for offline use.
- 2.3.4 Conduct a stakeholder hybrid workshop in Gauteng hosted by the service provider to solicit inputs.
- 2.3.5 Pilot the draft integrated audit tool for TB, HIV/AIDS and OLDs at the following commodities:
 - One gold mine.
 - One platinum mine.
 - One coal mine.
 - Two small scale mine.
- 2.3.6 Address the gaps identified in the pilot study and finalise the audit tool for TB, HIV/AIDS and OLDs.

The expected outcomes of the research are as follows:

- 2.4.1 Report on the literature review.
- 2.4.2 Report on the outcomes of the gap analysis.
- 2.4.3 Draft audit tool inclusive for TB, HIV/AIDS OLDs.
- 2.4.4 Report on the outcomes of the stakeholder workshop.
- 2.4.5 Report on the outcomes of the pilot study.
- 2.4.6 Revised audit tool for TB, TB, HIV/AIDS OLDs.
- 2.4.7 Draft final report and final audit tool.
- 2.4.8 Final report.

- 4.1.3 Bid documents must contain both technical proposal and pricing proposal (two envelope system).

A digital version on USB containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of

all tender documentation within the bid envelope. These serve as the original sets of bid documents and form part of the contract.

4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.
- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.
- 4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

At this stage the verification is to review bid responses for purposes of assessing compliance and governance with RFB requirements, whereby a bidder **will** be disqualified if they do not fully comply, it must be determined what documents are required to be returned by Bidders.

4.4 MANDATORY COMPLIANCE - CENTRAL SUPPLIER DATABASE

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury prior to submitting their bid (open tenders). Failure to being registered on the CSD and failure to submit the requested proof of registration on CSD information will lead to disqualification. The service provider acknowledges that he is fully aware of the provisions of the OHS Act 85 of 1993 and that he is an employer in his own right with duties and responsibilities as prescribed in the Act.

5. PART D: BID EVALUATION PROCESS

The evaluation process will be conducted in various stages. To move to the next stage of evaluation, the previous stage of evaluation must have been fully complied with.

5.1 REQUIRED EXPERIENCE

The service provider must have at least **5** years of experience in conducting applied research and the project team must have members with expertise in the following areas:

- 5.1.1 A minimum of **10** years' experience in occupational medicine in the SAMI.
- 5.1.2 A minimum of **10** years' experience in public health with particular interest in TB and HIV/AIDS.
- 5.1.3 A minimum of **5** years' experience in a software development.

Note: Bidders are to ensure that the team members used in the proposal must be the same team to execute the project. In instances whereby the team members resign, it is the bidder's responsibility to ensure they replace those resources with resources of the same expertise and experience.

5.2 EVALUATION PROCESS

The evaluation process will comprise of the following phases:

- Phase 1: Mandatory Evaluation.
- Phase 2: Functionality Evaluation.
- Phase 3: Pricing and Specific goals Evaluation.

5.2.1 MANDATORY EVALUATION PHASE 1

- Verify that mandatory requirements are met as per the bid document.

5.2.3 PRICE AND PREFERENCE (SPECIFIC GOALS) EVALUATION PHASE 3

- Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:
 - (i) **Price** with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.
 - (ii) **Preference** preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.

- b) <u>Counter Conditions</u>: MHSC. draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.
- c) <u>Collusion, Fraud and corruption:</u> Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.
- d) <u>Cancellation prior to awarding:</u> MHSC reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range or any process impropriety.
- e) Fronting: MHSC, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available. 21.5.
