OneStream is certainly well-positioned to respond to this RFP. However, it is important to note that our data centres are located in Europe, specifically Amsterdam, with a failover in Ireland. Could you kindly confirm if this would exclude our ability to respond to the RFP? In a recent interaction with JHB Water, they mentioned that if the required security measures are in place, the data centre could be situated outside South Africa.
