1. Query 1 (Sent via email dated 12/08/2025)

Can you please assist in addressing the following quires regarding the above-mentioned tender

- 1. Crane truck--- As per the document most work include planting of poles. Pulling of cables and conductors, transporting of materials to and from sites but I don't see the costing of crane truck please elaborate
- 2. OHM electrician---- Please elaborate on the scope of work for OHM electrician (in your scope you have put the scope for both OHM and Street light competency together)
- 3. Street light electrician---- Kindly elaborate the scope specific to the street light competent electrician (again you have put both scope as one)
- 4. Underground work------ Street light work(construction, fault or Maintenance)sometimes requires the UGM (underground work) what competency is required to do such scope as UGM is not catered for
- 5. Preferential points----- I see you are only allowing this point (20Points) to only 2 items woman and disability while the spectrum is so wide .what was the reason to only look at these two items for so many points

Please provide a prompt response on the above as I felt are matters of importance

Clarification for query 1:

- 1. An addendum notice was issued on august 20, 2025, updating the requirements to include a crane truck.
- 2. The scope of work is as outlined in the technical specification, and OHM competency also covers streetlighting.
- 3. This query is also addressed in point 2 above.
- 4. An addendum notice was issued on august 20, 2025, updating the requirements to include UGM competency.
- 5. The preferential points were allocated as per agreement with the SCM committee.

2. Query 2 (Sent via email dated 15/08/2025)

Please clarify the queries as detailed below, your assistance will be greatly appreciated.

- 1. The completed contract- the requirement state that it must be from the organ of state, does that exclude any work undertaken under private companies?
- 2. Retention- To confirm the 10% or when 5% kicks in.
- 3. CPG- The roll out plan to be submitted with tender or after the contract award.
- 4. Security bond- the letter of intent to quote which amount (tender Price)?

Clarification for query 2:

- 1. The specification template specifically requires information about contracts awarded by a organ of state.
- 2. The percentage retention on the amounts due to the Contractor is 10% (interim payments or progress payments). The limit of retention money is 5% of the contract sum (total contract value)
- 3. The CPG requirements are specified in the "Additional Conditions of Contract", which become effective once the contract is in place.
- 4. Securities, bonds and policies referred to on page 12 clause C.2.20 is not a requirement for this contract.
