2. SCOPE OF WORK - SPECIFICATIONS

The successful Bidder will provide the following groundwork maintenance services on request:

- Grass cutting (27 000 m²)
- Tree trimming
- Flower trimming
- Treatment of the pavement with weed-killer chemical (herbicide) (7000 m²)
- Picking up/clearing wastepaper/ tree leaves on the pavement and around the yard
- Weed control in the garden (Hand removal of weeds)
- Landscaping, including removal and placing back stones as well as cleaning or laying of weed shield.

The first phase of evaluation is checking and verification of all mandatory documents to be submitted by the bidders and compliance to specification.

Bidders are required to comply with the bidder requirements mentioned above.

Bidders that do not comply with the bid requirements may be regarded as non-responsive and may be disqualified.

2. PHASE 2:EVALUATION ON FUNCTIONALITY AND TECHNICAL SPECIFICATIONS

and minimum threshold as specified. The minimum qualifying score for functionality is **60**% as set out below. Bidders who fail to achieve the minimum qualifying score on functionality will be disqualified for further evaluation of price and preferential point system.

The minimum qualifying score for functionality is 60%.

3. PHASE 3: EVALUATION IN TERMS OF PRICE AND PREFERENCE POINT SYSTEMS

Only bids that achieve the minimum qualifying score/percentage for functionality will be evaluated further in accordance with the 80/20 preference point system prescribe in Preferential Procurement Regulations, 2022.

The PPPFA prescribes that the lowest acceptable bid will score 80 points for price. Bidders that quoted higher prices will score lower points for price on a pro-rata basis.

When calculating prices:

- a) Unconditional discounts will be taken into account for evaluation purposes; and
- b) Conditional discounts will not be taken into account for evaluation purposes but would be implemented when payment is affected.

- b. A specific goal will be allocated according to the percentage of ownership in the company (e.g., if black people own 50% of the company, the points for the specific goal will be 2, i.e. 50/100x4 = 2).
- c. Only the tender with the highest number of points scored may selected.CSD report will be used to as a means of verification of the specific goals.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
