DETAILED SPECIFICATION

REQUEST FOR SUPPLY AND DELIVERY OF CATERING SERVICES FOR THE DTIC GLOBAL EXPORTER PASSPORT PROGRAMME (GEPP) FROM 03 TO 06 FEBRUARY 2026 AT TRADE & INVESTMENT KWAZULU-NATAL.

1. INTRODUCTION

- 1.1 Trade & Investment KwaZulu-Natal is a South African trade and inward investment promotion agency, established as a Schedule 3C public entity, to promote the province of KwaZulu-Natal as an investment destination and to facilitate trade by assisting local companies to access international markets. In terms of the Public Finance Management Act, Act No.1 of 1999, as amended (PFMA), Trade & Investment KwaZulu-Natal, must fully comply with all the requirements of the PFMA and all other relevant and applicable legislation.
- 1.2 Trade & Investment KwaZulu-Natal is governed by the KwaZulu-Natal Trade and Investment Agency Act, 2010 (Act No. 05 of 2010). In terms of chapter 2 section 4 (1) of the KwaZulu-Natal Trade and Investment Act, the main functions of the entity are to:
- 1.2.1 Identify, develop, market and promote investment opportunities in the province to international and domestic investors.
 - 1.2.2 Develop the export capacity of the province.
 - 1.2.3 Develop the export market of the province.
 - 1.2.4 Foster trade and investment within the province.
 - 1.2.5 Develop a provincial investment and export plan for the development, promotion and marketing of inward investments and exports from the province.
 - 1.2.6 Keep and maintain a database of investment opportunities within the province in such a manner as to benefit all sectors of the economy.

2. BACKGROUND

The Department of Trade, Industry and Competition (the dtic), in collaboration with Trade & Investment KwaZulu-Natal, will be hosting a Global Exporter Passport Programme (GEPP). The training will be conducted over four (4) sessions over a period of three (3) months. This initiative is aimed at twenty (20) emerging businesses from KZN. The training is structured into four (4) phases, namely: Phase 1 - Introduction to exporting and export audit (25 – 28 November 2025); Phase 2 – Planning for Export & Market Selection (3 – 6 February 2026); Phase 3 – Entry strategy, sales and marketing (26 – 27 February 2025) and Phase 4 – Coaching Phase (9 – 13 March 2026).

3. PURPOSE

The purpose of this Request for Quotation (RFQ) is to request catering services for clients of EDPU during the upcoming Global Exporter Passport Programme (GEPP). This programme is designed to support qualifying companies in developing their own export marketing plans, enabling them to achieve significant progress in their targeted markets. EDPU strives to ensure a professional atmosphere, reflecting the importance of the training sessions and the value placed on clients.

- 5.1.3 The SBD1 form must be completed and signed by the authorised company representative.
- 5.1.4 The POPIA consent form must be completed and, signed by the authorised company representative.
- 5.1.5 The bidder must submit SBD 6.1 preference points claim form.

Failure to provide the above information may lead to bidder's proposal not being considered further.

5.2 Phase 2: Compliance with RFQ specifications

- 5.2.1 Quoting on less/ fewer items/ quantities than what has been requested will invalidate your quotation.
- 5.2.2 Only bid proposals that comply with RFQ specification will be further evaluated on price and specific goals scoring according to PPPFA 2022 regulations.

5.3 Phase 3: Price and Specific Goals Scoring

5.3.1 Pricing Considerations

- a) Bidders' price quotations must be inclusive of all applicable taxes (including VAT).
- b) Bidders' total price weighs 80 points.
