1. INTRODUCTION

CONTEXTUALISING THE ATLANTIS SPECIAL ECONOMIC ZONE

On 19 October 2018, the Minister of Trade and Industry designated Atlantis as a Special Economic Zone (ASEZ) in terms of the section 24 of the Special Economic Zones Act, No 16 of 2014.

The Atlantis Special Economic Zone is a geographical area of 118 hectares in the industrial area of Atlantis, Cape Town. It is a Greentech SEZ with the objective of attracting Greentech manufacturers. The ASEZ currently consists of five investors on privately owned land (about 25ha) as well as three separate portions of vacant and industrial zoned land previously owned by the City of Cape Town (+93ha).

ASEZCo is a Greentech focused special economic zone whose mission is to become Africa's leading, globally competitive, and export orientated Greentech manufacturing zone and a Living Lab demonstrating the highest standards of good governance, low carbon and resource efficient economic development and social inclusion (Annexure B).

2. SPECIFICATION

Scope of work

2.1 BACKGROUND AND CONTEXT

- The Atlantis SEZ prides itself as becoming the pinnacle hotspot of attracting Greentech investors into the Western Cape in particular Atlantis, while promoting diversity and inclusion amongst all stakeholders. It is essential that programmes such as this to be implemented in the workplace so that staff members are sensitive to workplace culture and how to conduct themselves. The Atlantis SEZ is currently undertaking various critical changes in the organisation which directly impact on the culture of the organisation and is thus seeking quotations from potential service providers on drafting a sexual harassment policy for the Atlantis SEZ and conducting a series of workshops over a 12 month period with the aim of creating awareness and education around harassment in the workplace.
