1.1 DESCRIPTION OF SERVICE: ...300 MM BOUDON TENSIO METERS (COMPLETE SET)

BACKGROUND: This is a new ARC/SADC collaborative project that officially commenced since April 2022. The project is entitled "Rootzone water and nutrient retention under vegetable production in soil amended with zeolite". Tensiometers are needed to measure soil water at the root zone of plants.

PURPOSE: The project will investigate the water retention ability of zeolite in sandy soil planted with Swiss chard and cabbage. The research will be executed in Eswatini with a partner based in University of Eswatini. Water scarcity is one of the limitations to vegetable production in Africa, including Southern African Development Community (SADC) Member States. Adding to the problems are climate-related droughts which have intensified irrigation water shortages in Africa, leading to low crop productivity. Improvement in the use of more water retentive production practices is needed to overcome these challenges. Soil amendments such as zeolite can be used to increase water retention ability of the soil and at the same time enhance more effective fertilizer consumption by the crop. Therefore, to determine water saving ability of zeolite and measure the water uptake of these two vegetables, tensiometers will be required. Each experimental plot will be fitted with a tensiometer to monitor soil water deficit at the root zone. The success of this project is attached to this equipment (tensiometers). This will enable the research project to capture data on the water use efficiency of both cabbage and Swiss chard cultivated on sandy soil amended with zeolite. Thereby, generating information and technologies that will lead to efficiency in crop-based agriculture. After the completion of the project, these tensiometers will be used for future research projects that require the monitoring of soil water contents.

SCOPE OF WORK: This is a three (3) year project which starts on 01 April 2022 and end on 31 March 2025. ARC researchers, academics from the University of Eswatini as well as post graduate students will be involved with the project.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
