Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC maintains a high level of security at the Dube TradePort precinct, which includes Civil Aviation Authority regulated Cargo Terminal and a demarcated Special Economic Zone.

DTPC seeks an appropriately PSIRA registered service provider to upgrade/replace the back-end CCTV infrastructure, provide integrated offsite monitoring; and related maintenance and support services on the Video Surveillance Management (VSM/CCTV) System and Access Control System and to provide a new electronic Visitor Management System at the Dube TradePort. This is to be met through the latest technological trends in the security industry in order to ensure that access control and all other security solutions within DTPC are integrated.

The PSIRA registered Service Provider must have the following strategic partnerships in place:

- CCTV/VMS (Video Surveillance Management System) partnership certification or a letter from a Vendor (OEM) as a reseller/partner;
- Proof of Open Network Video Interface Forum (ONVIF) Conformant Products or a letter from a Vendor (OEM); and
- IMPRO Certified Installer certificate.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- I. Enterprises (or bidders) who are at least 51% or more Owned by Black People.
