1. PURPOSE

The purpose of these terms of reference (ToR) is to invite bidders to submit a quotation to hire a high pressure jetting system to the Addo Elephant National Park as and when required.

3. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

4. SCOPE OF WORK

Addo Elephant National Park seeks to appoint a service provider for hiring of high pressure jetting system as and when the need arises. It is required from a service provider to allocate a high pressure jetting system to the Addo Elephant National Park for the duration of the contract (one year) to achieve optimum maintenance and prevent drains from overflowing and spillages.

Service Requirements:

1. Hiring of high pressure jetting system for sewer lines.
2. The high pressure jetting mechanism must be able to take out roots with an auger and eliminate FOG (Fat, Oil and grease)
3. Must at least be able to jet 262 mtrs per minute and have a minimum 120 bars.

4. Pressure jetting with cleaning nozzle – Rate only
5. Establishment for above, as and when requested – rate only.

5. SPECIAL CONDITIONS

- The General Conditions of Contract (GCC) as well as Special Conditions of Contract (SCC) forming part of this set of tender documents will be applicable to this tender in addition to the conditions of tender. Where the GCC and SCC are in conflict with one another, the stipulations of the SCC will prevail.
- The service provider may not assign or subcontract any part of the order without the written consent of the Addo Elephant National Park - SANParks.
- All safety procedures must be applied to in accordance with the Health and Safety Act. No workers may enter any sewer structures without proper safety equipment. If a contractor performs work without the proper safety clothes, his contract will be terminated immediately.
- The equipment of the successful contractor must be of good standard.
- All goods or services purchased will be subjected to inspection by SANParks management
- In the event that the supplier fails to render the service to acceptable standards, SANParks retains the right to take which ever steps are necessary to alleviate the situation. This may include the involvement of other service providers and the service provider will not have any claim because of the actions taken by SANParks.

6. FORMAL CONTRACT

The successful service provider will be issued with a Purchase Order, and will be required to sign an SBD 7.2 which shall form a contract between the two Parties, Addo Elephant NP & the service provider.

7. PROTECTION OF PERSONAL INFORMATION ACT, 4 OF 2013 (POPIA)

SANParks adheres to the Protection of Personal Information Act, 4 of 2013 (POPIA) requirements regarding personal information which came into effect 1 July 2021.

8. TIMELINES

The turnaround time for completion of maintenance work is 24 hours from receipt of purchase order.

9. FINANCIAL PAYMENT

Payment to the successful Service Provider will be made upon satisfactory service has been rendered and after receipt of valid invoice. Payment will be effected within 30 days of receipt of correct invoice.

10. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will

be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
