DTPC currently has several projects in the pipeline which includes the development of additional infrastructure. DTPC therefore requires the services of suitably qualified, experienced and independent Professional Service Providers to form a Panel of not more than three (3) Professional Service Providers for the provision of ad hoc professional services consisting of:

- Town and Regional Planning;
- Planning and Development Law;
- Urban Design;
- Landscape Architecture;
- Traffic Engineering;
- Development Economics; and
- Green Building Services.

The appointment of professional service providers will be for a period of three (3) years reckoned from the date of signing service level agreements with the DTPC.

#### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- I. Only Enterprises who are at least 51% Owned by Black People will be allocated (10 points); and
- II. The promotion of SMME's by subcontracting at least 30% to the bidder who are EME/QSE (10 points).
