In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for APPOINTMENT OF A PANEL OF A MAXIMUM OF 2 (TWO) SERVICE PROVIDERS FOR THE MAINTENANCE OF SURFACED ROADS, INCLUDING THE SUPPLY AND DELIVERY OF ASPHALT AND ASPHALT COMPONENTS FOR A PERIOD OF 36 MONTHS ON AN AS AND WHEN REQUIRED BASIS, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 5SB OR HIGHER.**

Only payments made in cash or debit/credit card will be accepted.

BS11/09/2025: APPOINTMENT OF A PANEL OF A MAXIMUM OF 2 (TWO) SERVICE PROVIDERS FOR THE MAINTENANCE OF SURFACED ROADS, INCLUDING THE SUPPLY AND DELIVERY OF ASPHALT AND ASPHALT COMPONENTS FOR A PERIOD OF 36 MONTHS ON AN AS AND WHEN REQUIRED BASIS " with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Room B207, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, before 12H00 on 11/11/2025. The tenders will be opened in public.

A non-compulsory clarification meeting will take place on 21/10/2025 starting at 10:00, at Electrical Workshop Boardroom, Municipal Stores (Magasyn), Cnr. Walter Sisulu Street & Wanderers Avenue, Middelburg.

Bidders will be evaluated on functionality whereby **70** points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **80** points will be allocated in respect of price and **20** points in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
