- Only bidders that passed functionality stage as stipulated in the tender document will be considered further for evaluation in which Price and Specific goals will be used.
- HDI/Designated groups and Locality will be used to claim points under specific goals.
- Proof of (CSD) Central Supplier Database Registration must accompany the bid document.
- Tax Compliance Status pin must be submitted.
- Proof of municipal rates and taxes not older than 90 days/lease agreement must be attached. In the case of a lease agreement, municipal rates and taxes of the landlord not older than 90 days must be submitted together with the lease agreement.
- No bid documents will be considered from a person in service of the state.
- Bids must be properly sealed clearly stating the tender reference number.
- The National Treasury general conditions of contract will be applicable to this tender.
- No correction fluid will be used on the document.
- Bids received after closing **TIME** and/ or **DATE** will **NOT** be considered.
