Prequalification: Only tenderers who meet the following prequalification criteria may respond:

- Copy of a valid SARS Tax Clearance Certificate with PIN;
- Original BBBEE Certificate or a certified copy thereof (Joint venture, consortium, or trust must submit a consolidated certificate). Failure to submit this certificate will lead to not getting points for BBBEE Level;

- A Company Profile with contactable references;
- Municipal Statement not older than three (3) months or Lease agreement if renting premises accompanied with an affidavit.
- A minimum of three Final Completion certificates and reference letters of similar work. (Completion certificate and Reference letters to be relative to the project at which the reference letter is issued)
- The proposed project Methodology and Fall Plan
- Tenderers with a minimum CIDB Grade 3 SN and CE/GB
