# SECTION A

## 1. BACKGROUND

The Social Housing Regulatory Authority (the "SHRA") was established in May 2010 by the Minister of Human Settlements in terms of the Social Housing Act, No. 16 of 2008. The SHRA is classified as a public entity listed under Schedule 3A of the Public Finance Management Act.

### 1.1 MISSION

To ensure there is quality housing for lower to middle-income households in integrated settlements by investing in, enabling, regulating, and transforming the social housing for rental market.

### 1.2 VISION:

To create an integrated south Africa where citizens live a good quality life in well-located and affordable, quality rental homes.

### 1.3 FUNCTIONS

- Promote the development and awareness of social housing by providing an enabling environment for the growth and development of the social housing sector.
- Provide advice and support to the Department of Human Settlements in its development of policy for the social housing sector and facilitate national social housing programmes.
- Provide best practice information and research on the status of the social housing sector.
- Support provincial governments with the approval of project applications by social housing institutions.
- Provide assistance, when requested, with the process of the designation of restructuring zones.
- Enter into agreements with provincial governments and the National Housing Finance Corporation to ensure the co-ordinated exercise of powers.

- 2.5.1 Bidders must complete all the necessary bid documents and undertakings required in this bid document. Bidders are advised that their bid should be concise, written in plain English and simply presented.

### Part 1: Invitation to Bid

Bidders must complete and submit the Invitation to Bid document.

### Part 2: Pricing Schedule

Bidders must complete and submit the pricing schedule document.

### Part 3: Declaration of Interest

Each party to the bid must complete and submit the Declaration of Interest.

#### **Part 4: Preference Points Claim Form in terms of the Preferential Procurement Regulations 2022.**

Bidders must complete and submit the Preference Points Claim Form.

A trust, consortium or joint venture:

- will qualify for points for their specific goals as a legal entity, provided that the entity submits their valid B-BBEE certificate OR a sworn affidavit in terms of the Amended B-BBEE Codes from Exempted Micro Enterprises (EMEs) of R10 000 000 annual turnover.
- will qualify for points for their specific goals as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

#### **Part 5: Broad Based Black Economic Empowerment Certificate**

Bidders are to submit an Original/Certified copy of a valid BBEE Certificate.

- A trust, consortium or joint venture will qualify for points for their specific goals as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid. OR a sworn affidavit in terms of the Amended B-BBEE Codes from Exempted Micro Enterprises (EMEs) of R10 000 000 annual turnover.

#### **Part 6: General Conditions of Contract**

Bidders must initial each page of the General Conditions of Contract and submit with their bid document.

#### **Part 7: Technical approach**

Bidder must at least:

Describe, in detail, exactly how they propose to carry out the activities to achieve the outcomes identified in the terms of reference. Bidders are required to have the basic office equipment and the resource/s (which must include, laptop, 3G connection, landline, own office with the basic office equipment) will be located within the region where the work will be done. They should identify any possible problems that might hinder delivery and indicate how they will avoid or overcome such problems.

Describe how the work will be managed. Provide an organisation chart clearly indicating:

- The lines of reporting and supervision within the bidder's team.
- The lines of reporting between the bidder and SHRA.

Identify the position(s) involved in the direct delivery of the service to be provided and in the overall management of the work and name the people who will fill these positions.

Describe the tasks, duties or functions to be performed by staff in these positions.

Indicate the number of hours required to complete each task and the number of hours to be provided by each team member. The bidder must be able to work within strict timelines and have the capacity to do so.

Provide information on any additional value-added services for consideration by SHRA, and which will form part of the overall proposed solution. Please note that the additional value ads must be priced separately in the space provided for in the pricing schedule.

Bidders are to present such information in a matrix. The following is provided merely as guidance. Bidders are free to elaborate as they see fit.

Provide a work plan of activities. In addition to providing details of the estimated number of workdays for each activity, bidders are to supply a detailed timetable that identifies when certain activities will be undertaken and over what period they will be spread. The timing of activities, the time needed to complete them, and the order in which they will be undertaken must be explained and justified.

Please note that part 10 should be no longer than 10 single-sided A4 pages in Arial 11 (font size).

**Part 8: Team Details**

The bidder must provide:

- A comprehensive curriculum vita (relevant to this bid and limited to two pages). In particular, the CV must highlight the team member(s) experience and qualifications to carry out the work

**Part 9: Experience in this field**

It is essential the service provider displays:

- Experience as set out in the terms of reference.
- The Bidder must provide at least three (3) reference letters on company letterheads of previous clients where the Bidder provided similar services.

**Part 10: Bidders National Treasury Central Supplier Database (CSD) Forms indicating the validity of bidder's registration.**

Bidders to submit confirmation from the National Treasury:

- a. Supplier Number
- b. Unique Registration Reference Number

**2.6 PRESENTATIONS**

2.6.1 SHRA reserves the right to invite Bidders for presentations before the award of this Bid. Only Bidders who have met the minimum functionality criteria will be invited to presentation.

**2.7 NEGOTIATION**

2.7.1 SHRA has the right to enter into negotiations with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.

2.7.2 SHRA shall not be obliged to accept the lowest of any quotation, offer or bid.

2.7.3 SHRA, issues this bid invitation in good faith; however, it reserves the right to:

- Cancel or delay the selection process at any time, without explanation,
- Not to select any of the respondents to this bid invitation, without explanation,
- Exclude certain services, without explanation.

2.7.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties. The designated responsible person of SHRA is the Chief Executive Officer or his/her written authorised delegate.

**2.8 REASONS FOR REJECTION**

2.8.1 SHRA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.

2.8.2 SHRA may disregard the bid of any bidder if that bidder, or any of its directors:

2.8.2.1 have abused the Supply Chain Management systems of SHRA.

2.8.2.2 have committed proven fraud or any other improper conduct in relation to such systems.

2.8.2.3 have failed to perform on any previous contract and the proof exists.

2.8.2.4 Such actions shall be communicated to the National Treasury.

### **3. TERMS OF REFERENCE**

#### **3.1 INTRODUCTION AND BACKGROUND**

- 3.1.1. An existing building located in the Germiston area - Gauteng Province has been earmarked as a potential site for development of Social Housing.
- 3.1.2. Currently the SHRA is in receipt of a Capital Grant funding application for this potential project submitted and the latter is under consideration.
- 3.1.3. A large part of the decision to invest Capital grant in a Social Housing project is informed by how financially and technically feasible the specific proposed project is.
- 3.1.4. SHRA therefore seeks to appoint a service provider to carry out a detailed Structural Integrity assessment on this existing building. The outcome of such assessment will be one of the key inputs in determining the technical feasibility of this project and ultimately the investment decision of the SHRA.
- 3.1.5. A site visit and a desktop structural analysis undertaken in recent past shows the following: The building consists of a basement, four floors and a partial fifth floor, with the roof being a combination of reinforced concrete slabs and a steel roof system covered with steel sheeting. The building comprises a reinforced concrete frame with infill brickwork. The floor slabs are cast in-situ and are supported by primary beams spanning to transfer beams. The transfer beams are supported by reinforced concrete columns, which, in turn, are supported by foundations.
- 3.1.6. Due to a fire that broke out in 2013 and thereafter the disuse of the building, in general the building does show signs of damage due to vandalism, neglect, water ingress, groundwater penetration.

#### **3.2 PURPOSE OF THE CONTRACT**

The work of an appointed service provider will include the following:

- 3.2.1. Current layout mapping of the building including systems such as plumbing, electrical, and other systems of the building.
- 3.2.2. Review of the recent desktop report and use this as part of the baseline for the detailed assessment.
- 3.2.3. Carry out a detailed assessment of the current structure to determine amongst others, the capacity and functionality (including structural soundness) to handle the proposed development objectives such as loading and increase of the unit numbers / yield, conformance to South African National Standards (SANS) regulations. The detailed

assessment to include the impact of the fire damage, water ingress, groundwater penetration and provide recommendation.

- 3.2.4. Assess the current structures' capacity to conform to the Social Housing Norms and Standards including green substantiable solutions such as a functioning borehole.
- 3.2.5. Provide advice and make recommendations to the SHRA and its stakeholders on the viability of the current structure.
- 3.2.6. Prepare and present the findings to a project steering committee.

### **3.3 DELIVERABLES**

The service provider must work towards delivery of the following:

- Draft structural integrity report
- Presentation of the report
- Final structural integrity report

The service provider will be required to present these reports to the SHRA and its stakeholders.

### **3.4 REQUIRED SKILLS AND EXPERIENCE**

The following are required skills and experience for this assignment:

- 3.4.1. Bidder/Team leader has minimum of five (5) years' experience in undertaking Structural Integrity assessments.
- 3.4.2. Team member/s has a minimum of three years (3) years of experience in undertaking structural integrity assessments.
- 3.4.3. Bidder/ team leader has done at least three (3) similar assignments / projects successfully in the past.
- 3.4.4. A team leader/ team members has qualifications and professional registrations with Engineering Council of South Africa (ECSA) in the following disciplines:
  - Structural Engineering

Provide concise CVs, Qualifications and Professional Indemnity (PI cover)

### **3.5 DURATION OF ASSIGNMENT**

The duration of this assignment will be two (2) months from the date of appointment.

### **3.6 SUBMISSION REQUIREMENTS AND FORMAT OF THE PROPOSAL**

The format of the proposal the bidder submits is required to be consistent with the structure of the functionality table below and demonstrate the following: (please clearly mark the various sections with dividers in your file submission)

## **Section 1**

Understanding of the required scope of work

Methodology and approach which include workplan, deliverables, timeframes and ideally matrixed with who in your team will be delivering the respective activities

Profile of the bidder

At least 3 Reference letters with contactable references confirming service provider successful completion of similar projects

## **Section 3**

Bidders are expected to provide an all-inclusive cost of this project with the following clearly indicated:

- Daily rate of each consultant with anticipated number of days to complete assignment
- Anticipated travel and disbursements
- Total cost of ownership on this assignment

Bidders are reminded that the SHRA will award the bid based on a bidder's total project cost and not hourly or daily rates. The bidders must ensure that the delivery of this project is within the required timeframes as stipulated in the Terms of Reference.

### **3.7 ACCOUNTABILITY AND REPORT**

- 3.7.1. The service provider will report to the Sector Development and Transformation Specialist who serves as a project manager for this project of the SHRA.
- 3.7.2. A Project Initiation Document will be developed and signed upon appointment which will outline the deliverables, timeframes, milestones, and disbursement schedule
- 3.7.3. The service provide will be required to compile intermediary project progress report on the project giving an outline of the work and progress of thus far achieved in the project. The service provider will also be required to compile all minutes of the meetings held on the project and associated action registers and submit to the SHRA within 48 hours of that meeting.

## 4. EVALUATION PROCESS

### 4.1. COMPLIANCE WITH MINIMUM REQUIREMENTS

4.1.1. All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further adjudication.

### 4.2. FUNCTIONALITY, PRICE, AND PREFERENCE POINTS

4.2.1. All remaining bids will be evaluated as follows:

4.2.2. The functionality calculation will be done based on the defined criteria and weighting thereof. Functionality will be scored out of a 100. If it is deemed necessary, presentations maybe held with Bidders who have met the minimum functionality criteria. If presentations are held, the functionality score will be adjusted whereby 80 percent will be awarded to during the bid evaluation and 20 percent will be for presentation score. **If a bidder fails to score a minimum of 70% out of 100% for functionality, the bid will be disregarded from further consideration.**

4.2.3. The second part will then be done on the 80/20 split whereby (80) points will be awarded for price and 20 points will be awarded for specific goals.

### 4.3. ELIMINATION OF BIDS ON GROUNDS OF FUNCTIONALITY

4.3.1. Bids that score less than 70% of the 100% available for functionality will be eliminated from further consideration.

4.3.2. The percentage scored for functionality should be calculated as follows:

4.3.3. Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score. The following formula should then be used to convert the total score to a percentage for functionality:

$$P_s = \frac{S_o}{M_s} \times A_p$$

where

$P_s$  = percentage scored for functionality by bid/bid under consideration

$S_o$  = total score of bid/bid under consideration

$M_s$  = maximum possible score

$A_p$  = percentage allocated for functionality

The percentages of each panel member shall be added together and divided by the number of panel members to establish the average percentage obtained by each individual bidder for functionality.

After calculation of the percentage for functionality, the prices of all bids that obtained the minimum score for functionality should be taken into consideration.

#### **4.4. PRESENTATIONS**

- 4.4.1 SHRA may decide to have compulsory presentations made by Bidders who met the minimum functionality criteria once the functionality score has been calculated.
- 4.4.2 Presentations shall only affect the marks awarded for functionality. If SHRA wishes to use presentations as an additional selection criterion between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme.
- 4.4.3 If the date of the presentation meeting is not indicated in the bid document, at least three days' notice will be given to bidders required to attend a presentation.
- 4.4.4 Presentations will be made to the full Evaluation Committee.
- 4.4.5 Points determined by the presentation will be awarded to each bidder by each member of the Evaluation Committee and then an average calculated.

#### **4.5. AWARDING OF PREFERENCES POINTS**

- 4.5.1. Points for specific goals will be awarded according to the table indicated in the preference points claim form(s).

#### **4.6. COMBINING PRICE AND PREFERENCE POINTS**

- 4.6.1. The specific goals marks for each bid will now be added to the price points for that bid
- 4.6.2. The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 4.5.1 or to a lower scoring bid based on firm, verifiable and justifiable grounds.

#### **4.7. ADJUDICATION OF BID**

- 4.7.1. The Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid based on firm, verifiable and justifiable grounds or no award at all.

## **5. EVALUATION CRITERIA**

### **5.1 Functionality Evaluation**

All proposals will be evaluated on the criteria provided in the table below. The proposals of all training providers will be rated on a scale

of 1 to 5.

- 1: Unacceptable, does not meet set criteria
- 2: Weak, less than acceptable. Insufficient for performance requirements
- 3: Satisfactory should be adequate for stated element
- 4: Very good, above average compliance to the requirement
- 5: Exceptional mastery of the requirement should ensure extremely effective performance

## **SECTION B**

### **1. SPECIAL CONDITIONS OF CONTRACT**

#### **1.1. GENERAL**

1.1.1. Proper bids for the services specified must be submitted.

#### **1.2. ADDITIONAL INFORMATION REQUIREMENTS**

1.2.1. During evaluation of the bids, additional information may be requested in writing from Bidders. Replies to such request must be submitted in writing, within five (5) working days or as otherwise indicated. Failure to comply may lead to your bid being disregarded.

#### **1.3. CONFIDENTIALITY**

1.3.1. The bid and all information in connection therewith shall be held in strict confidence by bidders and usage of such information shall be limited to the preparation of the bid. Bidders shall undertake to limit the number of copies of this document.

1.3.2. All bidders are bound by a confidentiality agreement preventing the unauthorised disclosure of any information regarding the SHRA or of its activities to any other organisation or individual. The bidders may not disclose any information, documentation, or products to other clients without written approval of the accounting authority or the delegate.

#### **1.4. INTELLECTUAL PROPERTY, INVENTIONS AND COPYRIGHT**

1.4.1. Copyright of all documentation relating to this contract belongs to the SHRA. The successful bidder may not disclose any information, documentation, or products to other clients without the written approval of the accounting authority or the delegate.

1.4.2. All the intellectual property (IP) rights arising from the execution of this Agreement shall vest in SHRA and the Service provider undertakes to honour such intellectual property rights and all future rights by keeping the know-how and all published and unpublished material confidential.

1.4.3. In the event that the service provider would like to use information or data generated by the service, the prior written permission must be obtained from SHRA.

- 1.4.4. SHRA shall own all materials produced by the Service provider during the course of this contract, or as part of the service including without limitation, deliverables, computer programmes (source code and object code), programming aids and tools, documentation, reports, data, designs, concepts and other information whether capable of being copyrighted or not (“IP”).

  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person’s conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
