### ERRATUM NO.1

**With reference to the above tender, kindly note the following:**

1. Paragraph 4 – the “Scope of Work”, which reads as follows:

#### **4.3 Building Compliance**

The building should meet the following statutory requirements:

**4.3.1 Certificate of Occupancy** – issued by Local Authority in terms of the National Building Regulations and Building Standards Act (please attach a certified copy).

**4.3.2 The Occupational Health and Safety (OHS) certificate** to be attached to the bidder’s response.

**4.3.3 An Electricity Certificate of Compliance (COC)** certificate to be attached to the bidder’s response.

**4.3.4** The building should allow for easily accessible entrance/exit to and from the building by staff, clients, and stakeholders. The building must make provision for perimeter access control which must be accessible to staff, clients, and stakeholders. Access for persons with disabilities must be made available.
