PART B TERMS AND CONDITIONS FOR BIDDING

1. BID SUBMISSION:

- 1.1. BIDS MUST BE DELIVERED BY THE STIPULATED TIME TO THE CORRECT ADDRESS. LATE BIDS WILL NOT BE ACCEPTED FOR CONSIDERATION.
- 1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED—(NOT TO BE RETYPED) OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.
- 1.3. THIS BID IS SUBJECT TO THE PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT, 2000 AND THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017, THE GENERAL CONDITIONS OF CONTRACT (GCC) AND, IF APPLICABLE, ANY OTHER SPECIAL CONDITIONS OF CONTRACT.
- 1.4. THE SUCCESSFUL BIDDER WILL BE REQUIRED TO FILL IN AND SIGN A WRITTEN CONTRACT FORM (SBD7).

2. TAX COMPLIANCE REQUIREMENTS

- 2.1 BIDDERS MUST ENSURE COMPLIANCE WITH THEIR TAX OBLIGATIONS.
- 2.2 BIDDERS ARE REQUIRED TO SUBMIT THEIR UNIQUE PERSONAL IDENTIFICATION NUMBER (PIN) ISSUED BY SARS TO ENABLE THE ORGAN OF STATE TO VERIFY THE TAXPAYER'S PROFILE AND TAX STATUS.
- 2.3 APPLICATION FOR TAX COMPLIANCE STATUS (TCS) PIN MAY BE MADE VIA E-FILING THROUGH THE SARS WEBSITE WWW.SARS.GOV.ZA.
- 2.4 BIDDERS MAY ALSO SUBMIT A PRINTED TCS CERTIFICATE TOGETHER WITH THE BID.
- 2.5 IN BIDS WHERE CONSORTIA / JOINT VENTURES / SUB-CONTRACTORS ARE INVOLVED, EACH PARTY MUST SUBMIT A SEPARATE TCS CERTIFICATE / PIN / CSD NUMBER.
- 2.6 WHERE NO TCS PIN IS AVAILABLE BUT THE BIDDER IS REGISTERED ON THE CENTRAL SUPPLIER DATABASE (CSD), A CSD NUMBER MUST BE PROVIDED.
- 2.7 NO BIDS WILL BE CONSIDERED FROM PERSONS IN THE SERVICE OF THE STATE, COMPANIES WITH DIRECTORS WHO ARE PERSONS IN THE SERVICE OF THE STATE, OR CLOSE CORPORATIONS WITH MEMBERS PERSONS IN THE SERVICE OF THE STATE."

1. PROJECT DEFINITION

- 1.1 Request for expression of interests and request for information to potential service providers to design, install and handover a complete working windows based electric fence system and mash wire for the SSA including consequent maintenance for a period of <u>five (5) years</u>; and
- 1.2 Maintenance of the existing clear vu fence and detection system for a period of five (5) years

2. OUTCOMES FOR THE PROJECT

- 2.1 The successful Bidder is required to supply, deliver, construct, install, wire, commission the electric fence system and mash wire ready for use that meet the following requirements:
 - Revamp the current infrastructure of the installed EFS.
 - Create a Multi Zone EFS that reports to the control room.
 - Revamp the double layers of the mash-wire protecting the EFS from the inside and outside.
 - Revamp the skirting and cabling 13kms running along the fence to the Main-Gate
 - Produce Design Drawings for the zoning of the EFS.
 - Install a Windows Based Software Monitoring System that indicates the Location of the Programmed Zones and enables remote viewing of multiple sites on a simple platform.
 - Install an SMS reporting module for reporting the status of the EFS.
 - Integrate the EFS to the Video Management System.
 - Issue an **Electrical Certificate of Compliance** for the installation.
 - Propose a Maintenance Plan of the EFS to ensure that the fence and infrastructure is in good condition and that it is operational and complies with legal requirements and best practices at all times.
 - Maintenance contract of the existing Clear Vu fence and 2 Wire Moduteg Fence Detection System.

3. Process

- 3.1.1 Potential bidders/service providers are invited to respond to this Expression of Interest (EOI)/Request for information (RFI). Through this stage bidders must meet the criteria stated and obtain positive security screening.
- 3.1.2 Only bidders who qualify from the EOI/RFI will be invited to a <u>Compulsory Briefing Session</u> where they will be provided with a <u>controlled document (confidential)</u> and invited to respond to the Request for Bids/Proposal. The service provider will be required to sign non-disclosure forms and others. Any unauthorised distribution and/or revelations of the contents of the document to unauthorised parties may lead to disqualification and/or cancellation of that service provider's proposal/offering.
- 3.1.3 Bidders must submit their bids or proposal within 21 days. Once the bid invitation closes, the bids will be evaluated using the criteria provided to identify a preferred bidder and/or runner-up bidder for appointment by the Accounting Officer.
