The scope of work will include the purchase, collection and removal of **SCRAP KVA TRANSFORMERS AND MINI-SUBS** within Eskom **LIMLANGA CLUSTER (LIMPOPO)**.

- The successful tenderer will be required to pay upfront for the allocated batch of 86 transformers and collect all units within 7 working days from the issue date of the approved work instruction / task order.
- The successful tenderer is expected to pay in full the units indicated on each batch submitted by Eskom Disposal Officer (and will not re-batch the quantities on the work instruction / task order).
