BS04/09/2025: PANEL OF MAXIMUM TWO (2) CIVIL CONTRACTORS FOR SUPPLY, DELIVERY, ERECTION & MAINTENANCE OF VENTILATED IMPROVED TOILETS WITHIN MP313 AREA AS AND WHEN REQUIRED FOR 36 MONTHS" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Room B207, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, before 12H00 on 22/10/2025. The tenders will be opened in public.

A **compulsory** clarification meeting will take place on 30/09/2025 starting at 11:00, at Mechanical Workshop Boardroom, Municipal Stores (Magasyn), Cnr Walter Sisulu & Protea Street, Middelburg, 1050.

Bidders will be evaluated on functionality whereby **70** points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **80** points will be allocated in respect of price and **20** points in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
