1. PURPOSE

the purpose of this exercise is to appoint a reputable supplier for the construction, supply, delivery and installation of concrete braais at the Tsitsikamma section of the Garden Route National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORKS AND PRICING SCHEDULE

1. Background and Scope

Tsitsikamma National Park – Stormsrivier Mouth requires the supply, delivery and construction of braai facilities, similar in size and configuration to the attached photograph.

The scope includes:

- Supply and delivery of precast concrete braai units
- Supply and delivery of precast concrete plinths
- Construction of brick-built support stands with two (2) wood storage compartments, including concrete footings

All works shall be suitable for outdoor, coastal conditions and heavy public use.

2. Description of the Braai Facility

Each braai facility shall consist of:

- One precast concrete braai unit (open-front firebox)
- One brick-built support stand providing two wood storage compartments beneath the braai
- One side preparation surface / table formed as part of the stand or plinth

The overall configuration shall closely resemble the photograph provided.

3. Technical Specifications

3.1 Precast Concrete Braai Unit



Approximate Dimensions (as per photo):

- Overall length: 1 500 mm
- Depth (front to back): 750 mm
- Height: 550 mm
- Firebox opening height: \pm 400 mm

Concrete Requirements:

- Minimum compressive strength: 28 MPa at 28 days
- Concrete shall be suitable for direct fire exposure and repeated heating and cooling
- Low moisture content, well-graded aggregates
- Proper curing to prevent cracking or explosive spalling

Firebox & Steel:

- Minimum of two (2) steel support bars cast into the firebox for braai grids
- High-yield reinforcing steel compliant with SANS standards

The braai unit must not crack, spall excessively, or explode under normal braai use.

3.2 Precast Concrete Plinth

- Precast concrete plinth to support the braai unit
- Minimum height: 500 mm
- Concrete strength: 28 MPa
- Flat, level top surface
- Sized to accommodate the braai footprint
- Suitable for outdoor and coastal exposure

3.3 Brick-Built Support Stand with Wood Storage

- Brickwork stand constructed beneath and around the plinth
- Two (2) wood storage compartments formed below the braai
- Approximate compartment size: 600 mm (W) x 500 mm (H) x 700 mm (D) each
- Brickwork to be clay bricks or cement bricks suitable for outdoor use
- Cement mortar Class II

3.4 Concrete Footings

- Concrete strip or pad footings beneath brick walls
- Minimum concrete strength: 20 MPa

- Footing depth and width sufficient for stability (minimum 200 mm wide x 200 mm deep)
- Compacted base prior to casting

3.5 Finish and Workmanship

- Neat brickwork with even joints
- Concrete surfaces free of honeycombing and sharp edges
- All work to be level, plumb, and structurally sound

3.6 Quality and Compliance

- All materials to comply with relevant SANS standards
- Contractor to replace any defective work or cracked units
- SANParks reserves the right to inspect works at any stage

5. MANDATORY DOCUMENTS

- Letter of Good Standing (To be submitted together with Health & Safety file by the successful bidder prior to commencement of the works).
- Company References: At least one (1) written reference letters from organisations where similar bricklaying, project was successfully completed.
- **Minimum Trade Requirements (Compulsory):**
 - **Bricklayer:** NQF Level 4 qualification or recognised Trade Certificate

Certified copies of qualifications or trade certificates for the required trade shall be submitted with the tender.

- **Trade-Specific References:**
 - Bidders shall submit at least one (1) reference letters or completion certificates for similar work completed under CIDB Grade 1GB, indicating experience in:
 - Bricklaying

Reference letter or completion certificate must clearly indicate the type of trade work performed. Combined reference letters covering the required trade will be accepted, provided the scope is clearly stated.

Additional Documents:

- Occupational Health & Safety File: includes OHS Plan, OHS Policy, Baseline Risk Assessment, Applicable Appointments etc. (To be submitted by the successful bidder prior to commencement of the works).

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

11. FINAL AWARD

Bidder who complies with the specifications and scores highest total points on PRICE and B-BBEE claimed points shall be awarded the contract. SANParks reserves the right to:

- Award the contract in full or partially
- Award to more than one bidder, and/or
- Not to award
- Re-advertise should the minimum of three written quotations not be received
- Not to award to the bidder scoring the highest points
- Not to award to bidders who have previously failed to deliver/ provided poor work.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS
