APPOINTMENT OF A PLUMBING SERVICE PROVIDER TO ASSESS AND THE PLUMBING SYSTEM OF SALGA VACANT BUILDINGS AT NO. 60 SURPRISE RIDGE ROAD HILLCREST – DURBAN, KWAZULU-NATAL

1. PURPOSE

The purpose of this document is to call for proposals from suitable plumbing service providers to assist the South African Local Government Association (SALGA) KZN owned vacant buildings with plumbing services, fix the leaking pipes / valves within the building structures.

2. KEY DELIVERABLES

- To inspect, assess the plumbing system and identify all faults and water leakages in the buildings.
- Replace or fix damaged plumbing accessories identified.
- Open, clean / blow out all pipes, fittings and traps used for sewerage and waste water drainage system;

3. PRE-REQUIREMENTS

The bidder will be expected to have visited and examined our premises prior to submitting a response to these Terms of Reference during compulsory briefing session and to have satisfied themselves as to the efficiency and correctness of their response for the proper provision of any of the above services.

Compulsory site visit to be Scheduled by SALGA and will be conducted a jointly site visit for all interested parties which will form a compulsory briefing session.

4. SPECIFIC REQUIREMENTS

Submissions should indicate whether the service provider or company is able to meet the following requirements.

- To provide service on an ad hoc basis.
- Valid Plumbing Trade Certificate should also accompanied the proposal.
- The service provider must be registered with the Plumbing Industry Registration Board (PIRB) of South Africa Or relevant plumbing regulatory body.

5. EXPERIENCE AND REFERENCES

The bidder should have at least minimum of five (5) years' experience with also minimum of three references for the similar type of services rendered

6. HEALTH AND SAFETY PLAN

Health and Safety Plan to be provided by service provider to protect its workers during the execution of the project. This include safe work practices since SALGA will not be responsible of any injuries and illness as a result of the service provider not protecting their workers. Health and Safety plan to be included in the proposal.

The project is once off. However, the appointed service provider will be expected to complete the project within the period of two weeks from the date of appointment.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
