Deliver first, then we'll vote for you, residents warn

Although a date for the upcoming local government elections has not yet been announced, political parties in Mzimba have already begun canvassing for votes.

But residents say they are tired of promises that are never fulfilled.

"Politicians promise us the world, but we need action," said Hazel Nemutsham, a resident of Mzimba. "We need water, jobs and basic services. Show us what you promise before we vote. If you promise water, drill the boreholes. If you promise jobs, hire locals, especially young people and those in need. We want deeds, not just stories," she said.

Mzimba has long struggled with an intermittent water supply, with some communities going for days without running water. Residents say similar promises were made during previous elections, yet little has changed on the ground.

In 2022, residents protested for a week demanding a consistent water supply, but little has changed, and they say they are still expecting intermittent supply.

A 35-year-old resident, who asked not to be named, said he is concerned about misinformation influencing voters.

Some people are being told that if they vote for another political party, they will lose their social grants. "That is not true," he said. "People should vote for a party that delivers services, not out of fear."

Residents say they want accountability and tangible improvements in their daily lives, not repeated commitments that fail to materialise after elections.

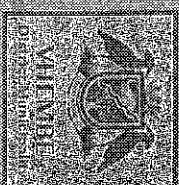
The Minister later posted another message in Tshenda, saying the Premier had indicated she was looking into the matter and that residents should report back if provincial officials did not visit the village within a month to provide clarity.

Residents say the message initially raised hopes, but claim the expected provincial visit never took place.

"I graduated in 2023. I then went to law school and started serving court orders in 2024. My articles expired in 2025. I recently wrote the last two of my heard exams and I am currently unemployed," she said. She described her situation as "unbearable and painful". "One has to work hard and take education seriously, but in the end my situation just became worse," Khakha added.

Nkomo acknowledged the high number of unemployed people, particularly graduates, in Vhembe and said urgent interventions are

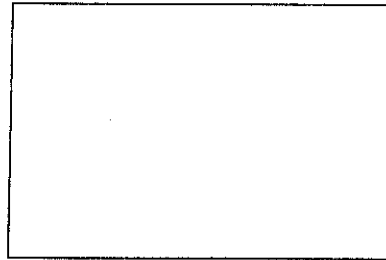

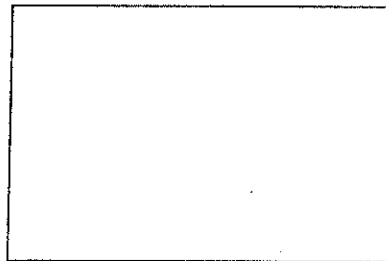

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
