SERVICE SPECIFICATIONS / TERMS OF REFERENCE

Experience in photography & videography services at similar research laboratories

1. Photography

Photography will range from portrait images of individuals to industrial photographs of **infrastructure / technologies / equipment / working environment through to 360-degree photospheres / panoramic images**, as well as panoramas. Photographs will need to be done using the most recent, innovative and creative photography techniques in order to present the various products, stages of construction, and business of the iThemba LABS in a captivating manner. These images should be able to reflect the world-class research and facility that is true for iThemba LABS. Photographs should be presented in high resolution TIFF and RAW format for large graphic printing, as well as JPEG or PNG that will allow for web-based publishing, with the option for inclusion in all print and broadcast spheres (television/digital video/analogue, etc.). These images need to contain IPTC information. The candidate service providers will need to show evidence, by presenting a portfolio of their ability and experience in using various techniques in order to capture images on film and how/ where these were used. The bidder's footage and photos must be submitted in low and high resolutions (of various requirements) will need to be made available of each image in order to facilitate the sharing of this information.

2. Video footage

The business of iThemba LABS requires that we often have to share information and conduct dialogue sessions that link our offices **across our two sites** and our partner organisations from across the globe. For this reason, for special events / strategic dialogue sessions, etc., we are required to provide high quality video images that allow for the optimal level of engagement through these internet-based meetings. Outside of this specific technical requirement, we will also require the filming of key events, public talks, et cetera, on video in the formats and of the quality that would allow for broadcast on various platforms (online, digital, analogue, television, etc.). Low and 4K resolutions /definition video footage (of various requirements) will need to be made available of each recording in order to facilitate the sharing of this information. On completion of the capturing of the video footage, an AV production of between 3-5 minutes needs to be provided, when requested.

3. Virtual Reality/360 Degree

The successful service provider needs to ensure that virtual reality videography is captured, and post production completed and needs to be submitted in a format which is ready for display and can be viewed using a google box or VR headset/ Oculus Rift sets. Additionally it should also be viewable on other platforms (mobile devices, browsers) and also be shareable offline.

The successful service provider also needs to ensure that 360 degrees images are captured, and post production completed and needs to be submitted in a format which is ready for display on multiple platforms (mobile devices, browsers, VR headsets) and also be shareable offline. The captured images need to be in high resolution with an output format of (2048 x 1024) JPEG format or similar.

4. Time Lapse Images

The successful bidder will be required to capture time lapse images of structural changes of the vaults over a period of time

5. Drone Footage

The successful bidder must have capacity to do drone footage using RFI drone equipment

6. Experience in photography & videography services at similar research institutions / laboratories

7. Cataloguing, filing and submission

All products need to be submitted to iThemba LABS in digital format. All the relevant images need to be completed with the necessary IPTC metadata, and sent in a version which is archived. **The associated courier costs / data download costs will be covered by iThemba LABS.** All data upload costs will need to be covered by the successful bidder. Within 36 hours following the conclusion of a commissioned assignment, the successful bidder needs to provide access to the required products. These products will need to be filed appropriately and each product labelled with a caption that includes the necessary information. 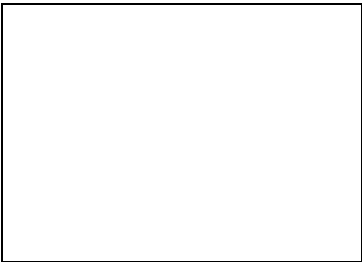
