TERMS OF REFERENCES FOR THE PROCUREMENT OF A SERVICE PROVIDER TO UNDERTAKE THE EXCLUSION APPLICATION OF THE MIDMAR WATER TREATMENT WORKS RESIDUES FOR UMGENGI-UTHUKELA WATER

Background & Business Needs

The primary function of Umgengi-Uthukela Water (Uuw) is to provide bulk potable water, bulk sanitation, and related solutions to local municipalities in its area of operation. Water treatment residues (WTRs) and wastewater sludge are the major waste streams that are produced during the operation of the treatment facilities. Thus, the management of these waste streams forms an integral component of the core business of the entity.

There are various WTRs management practices by the entity, including on and off site disposal, river discharges, land application for agricultural use etc. However, these practices are not sustainable when considering potential impacts on aquatic ecosystem when discharging to rivers, the environment around on-site disposal areas and the limited space at landfill sites. These potential environmental impacts have prompted Umgengi-Uthukela Water to apply for exclusion of the WTRs from the definition of waste in terms of GN R. 715. This exclusion application is also in line with South Africa's approach to waste management as presented in the country's National Waste Management Strategy (2020); which has embedded the concept of the "circular economy" where waste is seen as a new resource rather than waste to be discarded.

OBJECTIVES

The purpose for this submission is to appoint an independent and qualified Professional Service Provider (PSP) undertake the necessary application in accordance to the requirements of GNR 715 in order to obtain an exclusion of the Midmar Water Treatment Works WTRs from the definition of waste as per the Waste Act.

SCOPE


The competent Service Provider is required undertake the necessary application in accordance to the requirements of GNR 715 for Midmar Water Treatment Works. The competent Service Provider will be required to undertake the following tasks:

- DFFE Consultation Process
- Risk assessment and risk management plan for Midmar Water Treatment Works accordance with GNR 715..
- WTRs classification and assessment
- Undertake waste exclusion application together with all specialist studies in accordance with GNR 715.

MEETINGS

Corrections or revisions to the report and other documents prepared by the Service Provider are anticipated and shall be considered as part of the normal study process.
