- Reject Quotations submitted after the stated submission deadline or at the incorrect venue ;

Should a contract be awarded on the strength of information furnished by the Respondent, which after conclusion of the contract, is proved to have been incorrect, PRASA reserves the right to cancel the contract.

PRASA reserves the right to award business to the highest scoring bidder/s unless objective criteria justify the award to another Respondent.

## 13 ADMINISTRATIVE RESPONSIVENESS

## **PRASA GENERAL CONDITIONS OF PURCHASE**

### **General**

PRASA and the Supplier enter into an order/contract on these conditions to supply the items (goods/services/works) as described in the order/contract.

### **Conditions**

These conditions form the basis of the contract between PRASA and the Supplier. Notwithstanding anything to the contrary in any document issued or sent by the Supplier, these conditions apply except as expressly agreed in writing by PRASA.

No servant or agent of PRASA has authority to vary these conditions orally. These general conditions of purchase are subject to such further special conditions as may be prescribed in writing by PRASA in the order/contract.

### **Price and payment**

The price or rates for the items stated in the order/contract may include an amount for price adjustment, which is calculated in accordance with the formula stated in the order/contract.

The Supplier may be paid in one currency other than South African Rand. Only one exchange rate is used to convert from this currency to South African Rand. Payment to the Supplier in this currency other than South African Rand, does not exceed the amounts stated in the order/contract. PRASA pays for the item within 30 days of receipt of the Suppliers correct tax invoice.

### **Delivery and documents**

The Supplier's obligation is to deliver the items on or before the date stated in the order/contract. Late deliveries or late completion of the items may be subject to a penalty if this is imposed in the order/contract. No payment is made if the Supplier does not provide the item as stated in order/contract.

Where items are to be delivered the Supplier:

Clearly marks the outside of each consignment or package with the Supplier's name and full details of the destination in accordance with the order and includes a packing note stating the contents thereof; On dispatch of each consignment, sends to PRASA at the address for delivery of the items, an advice note specifying the means of transport, weight, number of volume as appropriate and the point and date of dispatch; Sends to PRASA a detailed priced invoice as soon as is reasonably practical after dispatch of the items, and states on all communications in respect of the order the order number and code number (if any).

### **Containers / packing material**

Unless otherwise stated in the order/contract, no payment is made for containers or packing materials or return to the Supplier.

### **Title and risk**

Without prejudice to rights of rejection under these conditions, title to and risk in the items passes to PRASA when accepted by PRASA.

## **Rejection**

If the Supplier fails to comply with his obligations under the order/contract, PRASA may reject any part of the items by giving written notice to the Supplier specifying the reason for rejection and whether and within what period replacement of items or re-work are required.

In the case of items delivered, PRASA may return the rejected items to the Supplier at the Supplier's risk and expense. Any money paid to the Supplier in respect of the items not replaced within the time required, together with the costs of returning rejected items to the Supplier and obtaining replacement items from a third party, are paid by the Supplier to PRASA.

In the case of service, the Supplier corrects non-conformances as indicated by PRASA.

## **Warranty**

Without prejudice to any other rights of PRASA under these conditions, the Supplier warrants that the items are in accordance with PRASA's requirements and fit for the purpose for which they are intended, and will remain free from defects for a period of one year (unless another period is stated in the Order) from acceptance of the items by PRASA.

## **Indemnity**

The Supplier indemnifies PRASA against all actions, suits, claims, demands, costs, charges and expenses arising in connection therewith arising from the negligence, infringement of intellectual or legal rights or breach of statutory duty of the Supplier, his subcontractors, agents or servants, or from the Supplier's defective design, materials or workmanship.

The Supplier indemnifies PRASA against claims, proceedings, compensation and costs payable arising out of infringement by the Supplier of the rights of others, except an infringement which arose out of the use by the Supplier of things provided by PRASA.

## **Assignment and sub-contracting**

The successful Respondent awarded the contract may only enter into a subcontracting arrangement with PRASA's prior approval. The contract will be concluded between the successful Respondent and PRASA, therefore, the successful Respondent and not the sub-contractor will be held liable for performance in terms of its contractual obligations.

## **Governing law**

The order/contract is governed by the law of the Republic of South Africa and the parties hereby submit to the non-exclusive jurisdiction of the South African courts.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

**SPECIFICATION AND SCOPE OF WORK****1. SCOPE OF WORK:**

- a) This Purchase agreement and Specifications covers repairs to electrical testing equipment that is utilised in KZN Rolling Stock for a period of thirty-six months.

**2. Definitions**

- a) Job-card hours:  
The maximum hours allowed for the contractor to refurbish a specific equipment. (See Annexure "A")
- b) Turn-around time:  
The maximum working days (Monday to Friday) allowed for a specific equipment to be in the possession of the contractor from date of Purchase Order (See Annexure "A")
- c) Material handling fee:  
The percentage of profit (**max 15%**) that the contractor is going to add to the price of the material/services needed to fix the equipment.
- d) Reference number:  
The number obtained from Maintenance Workshop Department, when the equipment is booked out and that must appear on the corresponding invoice.

**3. Duties of contractor****The duties of the contractor are to:**

- a) Be prepared to refurbish all emergency breakdowns within 24 hrs after the initial call from Metrorail (Contractor premises to be located within an 80 km radius from the KZN depot)
- b) Collect and deliver electrical testing equipment from Rolling Stock at Reliability Maintenance Workshop. (If necessary)
- c) Book out the equipment and obtain a reference number.
- d) Provide Metrorail with a written quotation (for their approval) before any work is carried out.
- e) Provide a price list from the supplier for spares required with the quotation. All spares procured must be listed.
- This must be submitted within ten working days from receipt of equipment.
  - The prices from the agents/suppliers will be verified by Metrorail
  - The contractor is only allowed to mark up prices to a maximum of **15%** on spares.
- f) Repair (to the satisfaction of Metrorail) within the maximum job-card hours allowed.
- g) Return the equipment to the Reliability Maintenance Workshop and Springfield within the turn-around time allowed.
- h) All replaced parts and components to accompany repaired machines to the Reliability Maintenance Workshop.

- i) Contractor shall be required to:
- Utilize the manufacturer's norms as per their maintenance manuals against which completed work is measured (tested) and accepted.
  - Execute inspections on a continuous basis to ensure that the agreed standards are adhering to.
  - Utilize efficient and reliable administrative control systems to produce the necessary invoices, defect reports and work order records.
- j) Once the equipment is returned to the Reliability Maintenance Workshop, the contractor shall also submit the job card to Metrorail (stating the level of refurbishment done) and the invoice for payment.
- k) Should the contractor suspect that the plant is being abuse due to operator default, he is to timeously report it to the Metrorail representative.

#### **4. Duties of Metrorail**

**Metrorail will:**

- a) Inform the contractor once there are equipment that needs to be repaired.
- b) Supply a book to be completed when machinery is issued and returned.
- c) Issue a reference number for all equipment that is booked out.
- d) Provide an area for the testing of returned machinery.
- e) Ensure a Purchase Order is submitted to the contractor before any work is executed.

#### **5. Measurement and Payment**

- a) Prices quoted shall be exclusive of V.A.T.
- b) The contractor labour rate shall include inter alia:
  - Testing and commissioning of machines.
  - All sundries e.g., Oil, rags, bolts, nuts, washers, cleaning chemical, etc.
- c) The contractor must ensure that the asset number/serial number of the machine as well as the corresponding reference number appears on the invoice. (The job-card and the original material's receipt/quote must be attached to the invoice.)

#### **6. General**

- a) The contractor is responsible for the safekeeping of all equipment in his possession. Any loss of, or damage to equipment (while in his possession) will be for the contractor's account.
- b) Metrorail will inspect workshops to ensure establishment of relevant Infrastructure.
- c) Metrorail do reserve the right to disassemble and strip any item that has been repaired to ascertain whether the repair was carried out on accordance with the prescribed specification, and the spares invoiced. Any irregularities will be reported to the contractor as well as Metrorail, who have the right to cancel contract/agreement.

## **7. Warranty**

### **All repairs to carry a warranty as follows**

- workmanship warranty of 6 months
- Material supplied – warranty of 30 days

## **8. Penalties:**

- Should the Contractor fail to deliver on the agreed date, a penalty of 1% per day will be charged on the total value of the Purchase order (PO) but will not exceed 10 percent of the total value of the PO.
- Metrorail KZN reserves the right to test the product at any given time during the contract period for compliance. The Supplier will be held liable with costs for any deviations in the specifications which may have resulted in damages and downtime to Rolling Stock equipment. A meeting will be convened by both parties (Metrorail KZN and the Contractor) to discuss the outcome of the investigation and costs incurred were necessary.

## **9. Compliance:**

- All non-conformances must be closed within 10 days and must be specified in your submission. Proof thereof must be provided in writing.
- Supplier must provide proof in a form of a letter indicating that all specifications listed will be met.
- Test/Inspection certificates to supplied for each component

## **10. Contract period and value:**

This contract shall commence within one week of its award and will be over a period of three years or attaining a value of R360,000.00 (three hundred and sixty thousand) VAT inclusive. The contract will terminate, either when the thirty-six months or the contract value is reached, whichever comes first

## **11. Price adjustments:**

- Items will be quoted on as per bill of quantity (BOQ) over a three-year period.
- All lines on the BOQ must be populated for all three years. Partial completion will lead to a disqualification.
