APPOINTMENT OF A PANEL OF WATER TANKER SERVICE PROVIDERS FOR THE SUPPLY AND DELIVERY OF POTABLE WATER DURING WATER INTERRUPTIONS AT THE SOUTH AFRICAN NURSING COUNCIL BUILDING FOR A PERIOD OF FIVE (5) YEARS

1. PURPOSE:

- 1.1 The South African Nursing Council (SANC) invites suitably qualified and experienced service providers to be appointed to a panel of water tanker suppliers for the provision of potable water during planned and unplanned water interruptions at the SANC building.
- 1.2 The appointed service providers will be required to supply, transport, and deliver potable water on an as-and-when-required basis, ensuring continuity of operations and compliance with applicable health, safety, and water quality standards for a period of five (5) years at the SANC's Cecilia Makiwane Building at No: **602 Pretorius Street, Arcadia, Pretoria 0008**.
- 1.3 The SANC plans to install a borehole water system that will be connected to the municipal water supply network. This will ensure the availability of potable water during municipal water interruptions in the area and support business continuity within the building.

2. BACKGROUND AND DISCUSSION:

- 2.1 The South African Nursing Council (SANC) has identified the need to appoint a panel of suitably qualified and experienced water tanker service providers to undertake the supply and delivery of potable water during planned and unplanned water interruptions at the SANC building.
- 2.2 The appointed panel will carry out all water distribution services as identified and instructed by the SANC Maintenance Team from time to time, on an as-and-when-required basis, for a period of five (5) years.
- 2.3 The water is to be delivered and pumped into a reservoir tank with an approximate capacity of 10,000 litres, located on the rooftop of a six (6)-storey building. Service providers must therefore have the necessary tanker capacity, pumping equipment, and technical capability to supply potable water and refill the rooftop reservoir efficiently and safely.

3. SCOPE OF WORK AND DELIVERABLES:

3.1 The scope of work entails the supply and delivery of potable water during planned and unplanned water interruptions at the SANC building at the Cecilia Makiwane building on an as and when required. The successful bidders shall be required to:

- Supply potable water that complies with South African National Standards (SANS) and relevant health regulations.
- Deliver water using licensed and compliant water tanker vehicles.
- Respond to emergency and scheduled water supply requests within prescribed turnaround times.
- Provide clean, safe, and potable drinking water delivery services on an as-and when-required basis throughout the contract period to ensure uninterrupted water supply during municipal water service interruptions.
- Ensure proper hygiene, maintenance, and sanitisation of water tankers.
- Submit proof of water source and water quality certification when requested.
- Adhere to all occupational health, safety, and environmental requirements.
- The system must include a centrifugal pump capable of pumping water vertically to a maximum height of 30 metres.

4. GENERAL REQUIREMENTS:

4.1 The service provider shall ensure that its team has relevant expertise and provide diligent and necessary support to the SANC when required.

4.2 The service provider will under no circumstance divulge, furnish, or disclose any sensitive information concerning the SANC or any other Stakeholders' activities to the public or news media. The SANC reserves the right to have confidentiality agreement signed with the successful service provider.

4.3 The service provider shall respond to call outs within 24 hours, of which emergencies must be attended to within two (2) hours. **NB: service provider must illustrate that they can respond to emergencies within two (2) hours.**

4.4 The appointed service provider shall follow all statutory provisions and safety rules for carrying this work including but not limited to SANS and the OHS Act, no 85 of 1993.

5. EVALUATION PROCESS

5.1 The SANC will evaluate all proposals in terms of the Preferential Procurement Policy Framework Act. No.5 of 2000 (PPPFA) and its regulations. A copy of the PPPFA regulations 2022 can be downloaded from www.treasury.gov.za. In accordance with the PPPFA, submissions will be adjudicated on **80/20** points system and the evaluation criteria. This bid will be evaluated in two (2) phases, namely: Administrative and Mandatory Compliance and Price & Specific goals.

Price Calculations

The following formula must be used to calculate points out of 80 for price in respect of an invitation for a tender with a rand value from R 2000.00 to or below R50 millions inclusive of all applicable taxes:

Ps = Points scored for price of bid under consideration

Pt = Price of bid or offer under consideration

Pmin = Price of lowest acceptable bid or offer.

ALLOCATION OF PREFERENCE POINTS BASED ON SPECIFIC GOALS.

The South African Nursing Council tenders will be evaluated on the following specific goals premised on addressing the legacy of apartheid's historical injustices, with a consideration on the following categories (of Historically Disadvantaged People - HDP) using race, gender, youth, and people with disability.

A maximum of 20 points may be awarded to a tenderer for the specific goal specified for the tender. The points scored for the specific goal must be added to the points for price and the total must be rounded off to the nearest two decimal places. Subject to section 2(1)(f) of the Act, the contract must be awarded to the tenderer scoring the highest points.

Preferential points will be allocated as per table below:

Black youth ownership points will be awarded to a Tenderer who has a 30% or more black youth ownership. Preferential points for black youth ownership will be awarded as follows:

Disability Ownership points will be awarded to a Tenderer who has a 20% or more disability ownership owners. Disability ownership will be determined by the % of the enterprise owned by such a person or by the % of shares owned by members who are actively involved in the day-to-day activities of the company or enterprise.

Preferential points for disability ownership will be awarded as follows:

Disability Ownership	80/20 Preference Point system
Tenderers who have 20% or more owners with disability	4
Tenderers who have less than 20% owners with disability	2
Tenderers who have 0% owners with disability	0

NB – The SANC will verify the Tax status outcome on the CSD report/ SARS e-Filing report:

- i. A bidder whose tax status is Non-Compliant will be notified of their tax matters and must meet their outstanding tax obligations within seven (7) days.
- ii. Should the bidder fail to provide a written proof of their tax compliance status within Seven (7) days, the SANC will reject the bid submitted by the bidder.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
