- 3 Quotations are to remain open for acceptance for a period of thirty (30) days effective from the date on which they are lodged and shall be accepted at any time within the said period of thirty (30) days.
- 4 Tenderers are requested to furnish the full registered name of the tendering company/supplier on the Form of Quotation and Form of Acceptance, Form B.
- 5 Tenderers are also required to sign each page of the Form of Quotation and Form of Acceptance, Form B, in the space provided at the bottom of each page.
- 6 **In the event of a mistake having been made on the price schedule it shall be crossed out in ink and be accompanied by an initial at each and every price alteration. SPECIFICATION

1. PURPOSE

The main purpose of this Request for Proposals (RFQs) is to appoint a suitably qualified service provider and implementing partner to:

- Render Project Management services to conceptualise, mobilise partners and resources (financial and non-financial) to promote key economic activities and niche industries as well as investment into the Inner City;
- Coordinate premium activities / events and projects that promote the niche economic activities in the inner city;
- Revive the inner city economic revitalisation as part of the Inner City Economic Development and Investment Roadmap and other interventions such as the Presidential Johannesburg Working Group on Inner City and Townships; and
- Increased competitiveness and innovation capacity of identified clusters.

2. LOCATION

This project is targeted for the confines of the Johannesburg Inner City (CBD). The Inner City of Johannesburg is important due to its central location in respect of the Gauteng City Region and the City of Johannesburg. The Gauteng City Region is the highest provincial contributor of South Africa's Gross Domestic Product (GDP) at 34%. The City of Johannesburg economy plays a central role within the Gauteng City Region although agglomeration economies are also significant, specifically the close proximity of Johannesburg, Tshwane and Ekurhuleni.

The focus is on three macro interventions namely spatial reconfiguration, township economy revitalisation and massive infrastructure investment. To this end five development corridors are planned one of which is a Central Development Corridor which sees the City of Johannesburg as the hub of finance, services, ICT and pharmaceutical industries, with a strong focus on regenerating the Inner City.

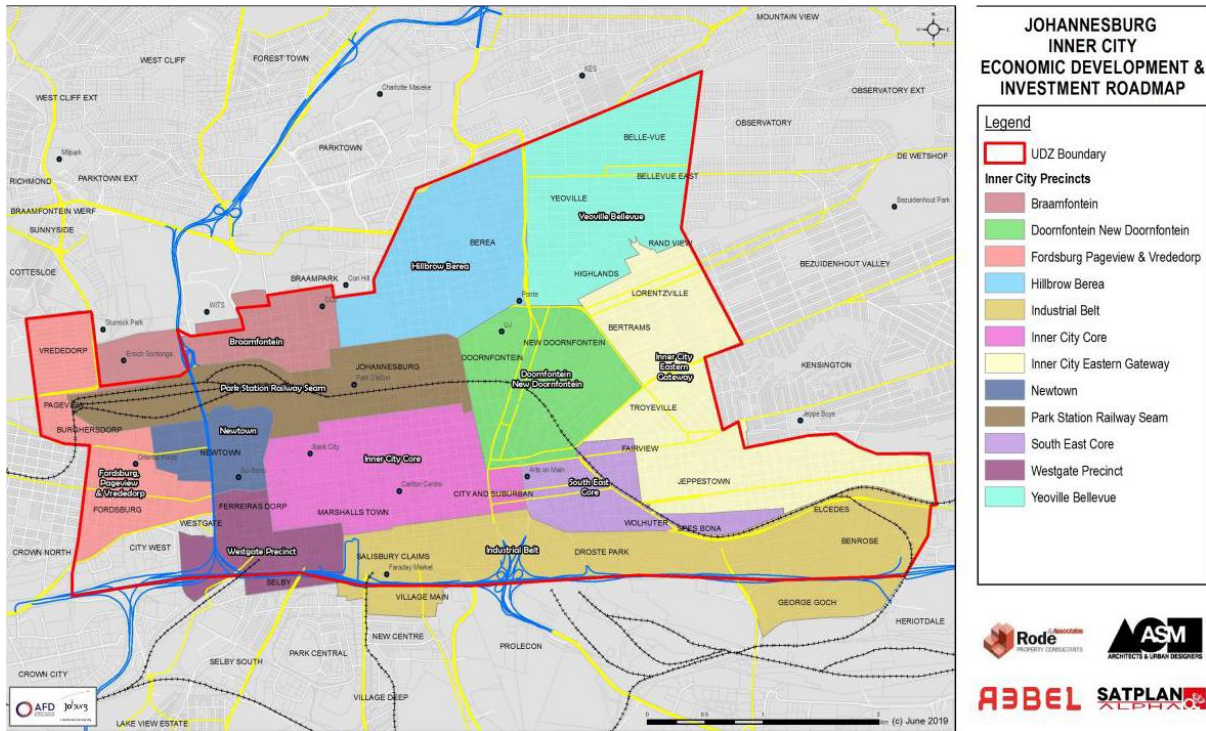


Figure 1: Map of Inner City - Region F

The successful bidder will be expected to present a proposal that entails the profiling of economic clusters in the Inner City and their value as well as recommend to the City interventions to promote investment into these economic nodes. This is also coupled with a proposal to project manage key events with the aim of showcasing areas of excellence in business and investment, tourism, urban management and rejuvenation interventions.

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

6.1. POINTS AWARDED FOR PRICE

6.1.1. THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

7. POINTS AWARDED FOR SPECIFIC GOALS

7.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

7.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
