2. Welcome

SANRAL welcomed everyone at the meeting.

3. Safety induction

The current Operator at the toll plaza presented a safety induction for all present.

4. Introduction

SANRAL explained that the meeting is a non-compulsory tender clarification meeting, for the contract N.002-223-2020/1 for the Operations and Maintenance of the N2 South Coast Toll Plazas.

The meeting will commence with a presentation by SANRAL on the background of the project and specifically the tender conditions.

This will be followed by a presentation by the consultant (MNA) on the Project Information and the Project specifications.

At the end, there will be opportunity for questions.

5. Background and Tender Conditions

SANRAL presented slides on the Tender conditions for contract N.002-223-2020/1. A copy of the presentation is attached in this Section A.

The presentation highlighted certain conditions of data as presented in the Tender Data (Part T.1.2) of the tender document.

The presentation further highlighted the Returnable Documents (as presented in Part T2.1 of the tender document).

The presentation concluded with a summary of typical errors that tenderer's have made in previous submissions.

6. Project Information, Contract & Specifications

MNA presented slides on the project background, and on the specifications of the project. The following items were covered:

- Description of the project
- Scope of work
- Programme
- Tender

- Plaza visits
- Housekeeping

MNA further explained the technical scoring that will apply to this tender, as presented in the Tender Data.

7. Questions and Answers

NO.	QUESTION	ANSWER
Q 1	<p>The tender requires the Tenderer to price for the replacement of UPSs on the route.</p> <p>Different size UPSs are to be priced. (These cost items are “if triggered” items.)</p> <p>The Consultant was requested to provide clarity on the required specifications, specifically the required run time.</p>	<p>MNA clarified that the specifications for UPSs is presented in the Standard Specifications, Volume 2 Book 3 (specifically Clause 16).</p> <p>The battery back-up time is specified in Volume 2 Book 3 as 30 minutes on 100% load.</p>
Q 2	<p>Tenderers queried the requirement to show relevant experience by providing proof of at least three similar or relevant projects, each to the value of at least R60 million.</p>	<p>SANRAL explained that the required monetary value of previous project experience, is a function of the expected value of the current contract.</p> <p>SANRAL further explained that the contract has requirements for the involvement of Targeted Enterprises (at least 30%) as well as the mentoring of a New Entrant (part of Targeted Enterprises), to provide for smaller contractors.</p>
Q 3	<p>Tenderers queried what contract will be signed between the Main Contractor and the Nominated Subcontractor.</p>	<p>MNA explained that SANRAL has a separate tender process for operations and maintenance of the N2 South Coast toll plazas (contract N.002-223-2020/1), and for the design, build, operations and maintenance of the toll system part of the works (contract N.002-223-2020/1NSC).</p> <p>The latter tender process will identify the Nominated Sub-contractor (NSC), who will then be appointed by the Main Contractor.</p> <p>The NSC tender document already includes all the forms and documents to be consolidated into the Contract document, and to be signed by the NSC and MC. This is similar to how the Contract document for the Main Contractor (i.e. contract between SANRAL and the Main Contractor) will be handled. The Contract document consists of:</p> <ul style="list-style-type: none"> • PART C1 AGREEMENTS AND CONTRACT DATA • PART C2 PRICING DATA • PART C3 SCOPE OF WORK • PART C4 SITE INFORMATION • PART C5 ANNEXURES <p>Part C1 include inter alia the Form of Offer, the Form of Acceptance.</p>
Q 4	<p>Tenderer's queried the involvement of 30% Targeted Enterprise.</p>	<p>MNA explained that the minimum requirement is 30% of the contract price, for involvement of Targeted Enterprises.</p> <p>The identification and procurement of Targeted Enterprises is explained in Part D of the tender</p>

		document, and will be done after appointment of the Contractor.
Q 5	Tenderer's queried whether specific CIDB ratings apply for this tender.	SANRAL clarified that no CIDB ratings are specified for the Contractor.
