1. **Essential administrative requirements:**

- 1.1. Valid current Tax Clearance Certificate and the pin code issued by the South African Revenue Services (SARS).
- 1.2. Only bidders registered on the Central Supplier Database (CSD) will be considered. Bidders shall include the CSD registration number with the bid proposal.
- 1.3.
