TENDER NOTICE AND INVITATION TO TENDER

Hantam Municipality hereby invites tenders for Tender No. NC065/ T05/ 2022: CALVINIA-EAST SEWER RETICULATION: PHASE II. The Works comprise the Construction of approximately 27km of subsurface sewer pipes in the existing residential and CBD area of Calvinia East.

Tender documents will be available from Monday 25th April 2022 from the offices of the Hantam Municipality at 20 Dr Nelson Mandela Drive, Calvinia during normal working hours (Mondays to Fridays) upon payment of a R599-00 deposit. This deposit is non-refundable and is payable in cash or by electronic transfer. Cheques will not be accepted.

Sealed tenders, marked: ***“Contract No. NC065/T05/2022: CALVINIA-EAST SEWER RETICULATION NETWORK: PHASE II”*** must be placed in the tender box at the Hantam Municipal Offices at 20 Dr Nelson Mandela Drive, Calvinia before 12:00 on Friday 27th May 2022. The tenders will be opened publicly directly afterwards.

Following conditions will apply to the tender:

1. Prices must be valid for ninety (90) days from tender closing date.
2. Prices quoted must be inclusive of VAT.
3. A firm delivery period must be indicated.
4. Bids will be evaluated in accordance with the applicable Preferential Point Scoring System as set out in the Councils Supply Chain Management Policy. The following forms, MBD 1, MBD 3.1, MBD 3.2, MBD 4, MBD 6.1, MBD 6.2 (including Annexure C, D and E) MBD 7.1, MBD 7.2, MBD 8, MBD 9 and the Certificate for Payment of Municipal Services must be completed and submitted with the bid. **Bidders are required to, together with their bids, submit an original and valid B-BBEE Status Level Verification Certificate thereof to substantiate their B-BBEE rating claims.**
5. Bids that are late or incomplete will not be considered, whilst the lowest or only bid will not necessarily be accepted. Bids per fax or e-mail will also not be considered.
6. At least a **Grade 7CE CIDB** registration is required to qualify for this tender.
7. **An original Tax Clearance Certificate/ Tax Compliance Status Pin for tenders as issued by SARS, must accompany the Tender Document. Tenders received without an attached original Tax Clearance Certificate for tenders, will not be considered.**
8. **Bidders must provide sound evidence in the tender document that they are financially and technically capable to complete the contract successfully.**
9. Bids must be accompanied with CIPRO documentation to verify ownership.
10. The 80/20 preferential points system, as determined by the Supply Chain Management Policy of Hantam Local Municipality, will be applied to evaluate this tender.

11. A Valid Central Supplier Database Registration Report (CSD Report) must be submitted with the bid offer.
12. Certified copy of the latest Municipal Account on the address of the Business and that of the Directors, as per CK1 must accompany the bid document (NB. Bidders may not be in arrears with municipal rates and service charges).
13. No tender will be considered to persons in the Service of the State.
14. The Municipality reserves the right to withdraw any invitation to tender, and/ or re- advertise, or to reject any formal tender. The Municipality does not bind itself to accept the lowest tender or award a contract to the bidder scoring the highest number of points. Potential bidders should also note that all projects in terms of this tender may not materialize.
15. Only Locally produced goods or locally manufactured goods, meeting the stipulated minimum threshold for local production and content, will be considered. **The Local Content regulations are a pre-qualification for this contract.**
16. The tender document must be completed in Black Ink. Computerized/ typed tenders will be disqualified.
17. The tender document must be completed on the original tender document. Copies of the tender document or parts thereof will render the tender document non- responsive.
18. **This Tender will be subject to a Contract Participation Goal of 30% of the Contract Value which must be subcontracted to EME's and QSE's having at least 51% black ownership.**

A **Compulsory Site Visit/Clarification Meeting** with representatives of the Employer and the Engineer will take place at the Commando office of Hantam Municipality in Calvinia on **Tuesday 3rd May 2022** starting at 10h00, whereafter a site inspection will take place. The doors will be locked at 10h00 promptly, after which no further Tenderers will be allowed to enter.
