1. INTRODUCTION AND PURPOSE

In line with legislation there are specific requirements to be met in the recruitment and selection of top management officials, of which competency assessment is one. The City of Tshwane utilises external service providers for this purpose.

2. BACKGROUND

Provide the background detail of the bid:

The Regulations on Appointment and Conditions of Employment of Senior Managers (Government Notice No.21, published in Government Gazette No. 37245 of 17 January 2014), stipulates specific requirements to be met in the recruitment and selection of senior managers (City Manager and officials directly reporting to the City Manager). The City of Tshwane (CoT) utilises these requirements for appointment of officials in other top management positions as well.

In line with the abovementioned legislation the City utilises external service providers to assist with specific tasks during the recruitment and selection process of top management positions, of which competency assessment is one.

CoGTA has developed specific competency assessments for municipalities, which can only be administered by CoGTA-accredited service providers.

3. PROJECT SCOPE

The service provider(s) to be appointed will be expected to render the following services to the CoT:

- A service provider will be expected to conduct competency assessments for candidates who are recommended for appointment in senior and top management positions in the City of Tshwane.
- The competency assessments must be those that were specifically developed by CoGTA for municipalities.

4. VALIDITY PERIOD

The validity period for the tender after closure is 90 days.

- > Submit a clearly defined proposal indicating the following:
 - The type of competency assessment to be utilised
 - Indication of the turnaround time for competency assessments and issuing of reports

Failure to submit the above will automatically lead to disqualification to the next phase.

If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.
