1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The Mine Health and Safety Council (MHSC) is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on Mine Health and Safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of mining MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

The use of Self-Contained Self Rescuers (SCSRs) has been an integral part of escape strategies in South African Mines for over thirty years. These escape strategies require employees who find themselves in an irrespirable atmosphere to utilize the life-sustaining capacity of the SCSRs to reach the nearest place of safety (refuge bay or fresh air station), where the atmosphere is respirable and free from contaminants.

In 1988, the Chamber of Mines Research Organisation (COMRO) published the results of extensive research based on the measured ventilatory demands of test subjects under controlled simulated escape conditions. This information was used to develop a guideline for the calculation of "safe travelling distances" when using SCSRs (COMRO guideline No.10 "Res-Q-Pacs – How to calculate safe travelling distances"). This guideline has been used, in conjunction with the SCSR rated duration certified through the SANS 1737 process, to position and distribute refuge bays in the underground workings as a significant component of mines rescue and escape strategies.

Currently, SCSRs used in the SAMI must be certified by the South African Bureau of Standards (SABS) in accordance with protocol SANS 1737 (Body-worn escape type breathing apparatus). The SANS-rated duration is the principal indicator used in determining the location and spacing of refuge bays underground. The refuge bay is situated within the distance that the worker can travel from the working place to the refuge bay using the provided SCSR. Location of refuge bays must consider the employees' anticipated breathing rate and oxygen demand while negotiating the escape route to the refuge bay. These considerations are necessary in matching the distance to be travelled with the rated duration of the SCSR in service.

The ventilation demand of a mine is influenced by several factors, including number of people, an individual's breathing rate and intensity, which, for self-escape, are dependent on the dimensions and inclination of the escape route. The breathing rate is dependant on the posture of persons during the escape and therefore the required physical effort, which is in turn a function of the physical fitness of the individual. The breathing rate demand also depends on the size and body mass of the individual. Lower levels of fitness result in higher oxygen demand for the same work-rate. Therefore, individuals with different fitness levels, size and body mass will have different breathing rates resulting in different effective SCSR duration for the same certified rated duration over the same escape route. This information must be used to ensure that all refuge bays are well within the distance that workers can travel using the provided SCSRs along the designated escape route.

The COMRO guideline which has been used successfully by the SAMI for over 30 years, is due for revision to account for advancements in areas such as technology, mine design and the understanding of the factors which influence the calculation of a safe travelling distance. This project aims to update the COMRO guideline No.10 "Res-Q-Pacs – How to calculate safe travelling distances and develop the MHSC User Guide on SCSRs – How to calculate safe travelling distances. In commissioning an update to this SCSR User Guide (UG), the following must be addressed:

- New generation Self-Contained Self-Rescuers are in use. This must conform with the latest version of SANS 1737 (Body-worn escape type breathing apparatus) with which all SCSRs used in South African mines must comply.
- A major issue is that the information used to define the individual breathing (ventilatory)
 rates is based on laboratory tests performed on very fit individuals (Mine Rescue Services
 team members). The concern is that these individuals are not representative of (male and
 female) mineworkers and could well underestimate the ventilatory demands of a more
 representative cohort.
- The outline of the guideline has proven to serve adequately all types of mining operations issuing SCSRs to workers as part of their risk-based emergency escape procedures. This approach is to be considered in structuring a new MHSC User Guide, albeit making use of modern communication tools other than printed media for training and (escape procedure) design purposes.
- There has been advancements in SCSR technology, improved oxygen generation achieved by new SCSRs and make thereof.
- There has been an introduction of women in mining (WIM) who use SCSRs.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT

MHSC intends to appoint a service provider to review the COMRO Guide 10 "Res-Q-pacs-How to calculate safe travelling distances" and develop the MHSC User Guide on SCSRs – How to calculate safe travelling distances.

2.2 CONTRACT PERIOD

The duration of this project is expected to be **24 Months**.

Note: The **21 months** will be allocated towards the project work.

The **3 months** will be allocated to MHSC administrative duties, such as project initiation, contracts, and project closeout.

2.3 DETAILED SPECIFICATIONS/SCOPE OF WORK

The service provider will be required to undertake the following as part of the scope of work:

- 2.3.1. Review local and international literature on methodologies for calculating oxygen consumption rates during work for male and female individuals using SCSRs in the mining and other relevant industries. The literature review must address ventilatory demands of the population represented in the workforce (e.g. male or female, differing fitness levels, different body dimensions).
- 2.3.2. Develop a methodology for testing which include the following:
 - a) The different tests that will be conducted to establish representative oxygen consumption rate of a characteristic cohort male and female mine workers when travelling over the different types of terrain that make up the different escape scenarios in underground narrow reef and massive orebodies mechanised mines.
 - b) A representative number of SCSRs for each category: chemical oxygen generators (two makes) and compressed air units (one make). The "representative number" must correspond to SABS batch requirements when a unit is tested for conformance. The units must be tested in terms of SANS 1737 procedure 4.17.1 to verify the "rated"

- duration" of each SCSR and assign a nominal "rated duration" baseline for the purpose of this work (Table 1).
- c) Tread mill testing in a controlled laboratory environment to simulate different mining terrains (Table 2) to determine the oxygen demand for different individuals and different terrains. Aside from simulating different mining terrains, the laboratory facility should provide a variable, controlled environment that may be assessed in terms of air temperature, air velocity and humidity (air cooling power). Varying environmental conditions should be used as a further comparative parameter to assess the impact this will have on the breathing rates and physical strain. The critical performance characteristics determined shall include (but not limited to) oxygen supply, carbon dioxide scrubbing, breathing resistance and temperature of the inhaled gas mixture from the SCSR unit.

Note: The results of the laboratory tests will be used to generate a set of data (Table 1 in the COMRO User Guide), to better inform responsible mine official in the determination of viable escape routes and location of refuge chambers within the effective duration of the SCSR. Effective SCSR duration (SANS 1737 Definition 3.5)" depends on the work rate of the user and this, in turn, will be determined by escape route conditions".

- 2.3.3. Conduct tests as per the approved methodology.
- 2.3.4. Determine the methodology based on the data generated in 2.3.2. to calculate safe travelling distances for escapes using SCSRs, considering the different types of terrain that make up the different escape scenarios in underground narrow reef and massive orebody mechanised mines.
- 2.3.5. Service provider must conduct a hybrid workshop in Gauteng to present the findings of the study to relevant stakeholders and solicit further inputs.
- 2.3.6. Use data collected in this project to develop a guiding document that can be used to position refuge bays safely within the rated duration of the SCSRs in use at a specific mine, taking the following into account:
 - i. The ventilation rates of workers in self-rescue escape scenarios.
 - ii. The rated SCSR durations as per SANS 1737.
 - iii. The types of terrain included in the escape route.
- 2.3.7. Produce the new *MHSC User Guide on SCSRs How to calculate safe travelling distances*, considering, but not limited to, the following:
 - i. The advancements in SCSR technology and make thereof.
 - ii. Compliance with the requirements of SANS 1737.
 - Improved rates of oxygen generation achieved by new SCSR technology.
 - iv. The introduction of WIM.

- 4.1.3 Bid documents must contain both technical proposal and pricing proposal (two envelope system).

A digital version on USB containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope. These serve as the original sets of bid documents and form part of the contract.

4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.

- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.
- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.
- 4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

At this stage the verification is to review bid responses for purposes of assessing compliance and governance with RFB requirements, whereby a bidder **will** be disqualified if they do not fully comply, it must be determined what documents are required to be returned by Bidders.

4.4 MANDATORY COMPLIANCE - CENTRAL SUPPLIER DATABASE

5.1 REQUIRED EXPERIENCE

The service provider must have at least **5** years of experience in conducting applied research and the project team must have members with expertise in the following areas:

- 5.1.1. At least one team member with a minimum of **5** years of experience in conducting physiological laboratory and/or field stress tests on humans.
- 5.1.2. At least one team member with a minimum of 5 years of experience in conducting SCSR functional tests in accordance with SABS 1737 requirements. Adequate knowledge and understanding in the practical use of SCSRs in underground escape situations is required.
- 5.1.3. At least one team member with a minimum of **10** years of experience as a Section 12.1 appointee (underground mines) under the MHSA, No. 29 of 1996, as amended.

- 5.1.4. At least one team member with a minimum of 5 years of experience in mining engineering.
- 5.1.5. At least one member with a minimum of **5** years' experience in medicine specialising in pulmonology or respiratory health.

Note: Bidders are to ensure that the team members used in the proposal must be the same team to execute the project. In instances whereby the team members resign, it is the bidder's responsibility to ensure they replace those resources with resources of the same expertise and experience.

5.2 EVALUATION PROCESS

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury's General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

(a) Disclose the confidential information to any third party, or

(b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party. The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with The Mine Health and Safety Council (MHSC) or in the possession of the recipient prior to its involvement with The Mine Health and Safety Council (MHSC);
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from The Mine Health and Safety Council (MHSC), or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform The Mine Health and Safety Council (MHSC) of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from The Mine Health and Safety Council (MHSC) to do so, return to The Mine Health and Safety Council (MHSC) all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from The Mine Health and Safety Council (MHSC)
- (b) All written transcripts of confidential information disclosed verbally by the The Mine Health and Safety Council (MHSC) and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
