

SPECIFICATION FOR THE PROVISION OF AVIATION SECURITY FOR SCREENERS (LEVEL 1) REFRESHER TRAINING (PASSENGERS AND BAGGAGE) IN TERMS OF PART 110 AND 109

1. INTRODUCTION

- 1.1 Civil Aviation Regulations - Part 109.01.1(6) states: Level 1 and 2 shall be valid for one year and persons in these categories shall undergo refresher training every 12 months. Persons failing to undergo refresher training within 13 months from date of completion of previous training shall undergo initial training.

2. PURPOSE

- 2.1 Gateway Airport Authority Limited (GAAL) seeks to appoint reputable, and suitably qualified in terms of Part 109 of the Civil Aviation Regulations - ASTO to provide AVSEC for Screener refresher training (Level 1) to ten security staff members. The training shall be attended to at the training provider's facilities.

4.1 Gate 0: Administrative (mandatory) requirements
