# 1. INTRODUCTION

1.1 Civil Aviation Regulations - Part 109.01.1(6) states: Level 1 and 2 shall be valid for one year and persons in these categories shall undergo refresher training every 12 months. Persons failing to undergo refresher training within 13 months from date of completion of previous training shall undergo initial training.

#### 2. PURPOSE

2.1 Gateway Airport Authority Limited (GAAL) seeks to appoint reputable, and suitably qualified in terms of Part 109 of the Civil Aviation Regulations - ASTO to provide AVSEC for Screener refresher training (Level 1) to ten security staff members. The training shall be attended to at the training provider's facilities.

# 4.1 Gate 0: Administrative (mandatory) requirements

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
  - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
