## **1. INTRODUCTION AND PURPOSE**

Quotation for the supply and delivery of ornamental plants and seeds to the Tshwane Municipal Nursery as and when required for a period of 1 year to supply the nursery with ornamental plant seeds and vegetable seeds for propagation.

The Department is looking for one supplier to supply all the plants and seed required for this quotation.

The quotation includes the following items:

## **2. BACKGROUND**

The ornamental plants seeds are propagated twice a year providing summer and winter ornamental seedlings for the key tourist attraction parks in the city like

Burgers Park, Magnolia Del, the City Hall etc. The nursery propagates the seedlings and then supplies them for the beautification of the city.

The vegetable seeds are propagated as and when required. Once the seedlings are large enough, they are distributed through the Agriculture and Rural Development Division to their community projects. The vegetable seedlings are also distributed on special event days like Nelson Mandela Day and International Food Security Day.

The seed is required by Nursery Operations of the Environmental Management and Parks Division.

### 3. PROJECT SCOPE

#### Specifications for The Ornamental Plant and Vegetable seeds

##### 3.1 Quality of ornamental seed

- Annual/ornamental plant seed is usually graded. Most seeds are available as F<sup>1</sup>, F<sup>2</sup> or F<sup>3</sup> hybrid seed. The City of Tshwane is only interested in the best quality available.
- The seed provided by the wholesale seed supplier must be guaranteed so that if the germination is poor then the service provider will replace the seed. If the supplier requires that the seed be sown in a specific way to guarantee the seed, then such guidelines must be provided upon delivery.
- The seed will be procured per 1000 seeds per packet or per gram depending on the type of seed.

##### 3.2 Ornamental Plant and Vegetable seeds to be supplied.

The City requires the following seed to be supplied.

## 5.2 MANDATORY REQUIREMENTS

The following letter of consent must be submitted with the quote. It must be on the Seed suppliers letter head and must be signed by the supplier's representative.

The bidder must attach a signed letter from a Bulk South African Seed Supplier (on their letter head) (not retailer like a supermarket or local nursery) confirming that they agree to supply the seed to the bidding person or company and confirm the quality of the seed as the City of Tshwane is only interested in the best quality seed available. (This includes items 1/2/3/4)

The bidder must provide a letter of confirmation to supply from the nursery of the ornamental seedlings and vegetable plants in trays and the ornamental trees. ( This includes items 5/6/7)

#### **5.4 Preferential Points System**

The preferential points to be used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for specific goals
  - Bidders are required to submit supporting documents for their bids to claim the specific goal points.
  - Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.
  - Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.
