DESCRIPTION OF THE PROJECT

1. SUPPLY AND DELIVERY OF HONEY SUCKER TRUCK FOR DR. J.S MOROKA LOCAL MUNICIPALITY

Nkangala District Municipality ("NDM") intends procuring Honey Sucker on behalf of Dr. J.S. Moroka Local Municipality. The Tenderer shall on appointment by NDM Supply and Deliver Honey Sucker Truck to Dr. J.S. Moroka Local Municipality.

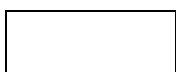
The Tenderer's prices shall include registration of the Truck in the name of Dr. J.S. Moroka Local Municipality.

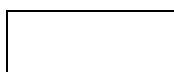
Description of the goods required

The Supply, Delivery and Registration of the Honey Sucker Truck must consist of the following specifications.

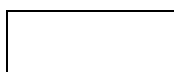

- a) The equipment shall be a new, currently advertised and produced product of a well-established manufacturer of this type of product. The successful bidder shall satisfy the Council that he is maintaining a branch or store within a reasonable distance from the working location of the machine, staffed for securing parts within a reasonable length of time.
- b) The equipment is to comply in all respects with the Road Traffic Ordinance and will be complaint with registrations as required by the NATIS system.
- c) Bidders must submit with their bids specifications and drawings to ensure that the equipment offered, complies with the Council's requirements.
- d) The successful Tenderer must register and fit license plates to the truck prior to delivery.

2. **Transmission**

PTO drive shall be standard equipment on this transmission

3. **Brakes**

A parking brake with hand lever shall be provided.
Air operated brakes and exhaust brake must be fitted as standard.

4. **Steering**

Power assisted steering must be fitted as standard,

5. **Electrical system**

Immobilizer system must be fitted as standard equipment.

6. **Wheels and Tyres**

- a) Rear: Tyres suitable for road usage must be provided.
- b) Front: Tyres suitable for road usage must be provided.
- c) A spare tyres, per model, for the front and rear respectively, and the suitable rims must be tendered as standard equipment.
- d) Vehicles with the same size rear and front wheel shall receive preference,
- e) A suitable jack and wheel spanner with an extended handle must be fitted as standard

7. **Instrumentation Minimum requirements**

- a) Engine temperature gauge,
- b) Electrical fuel gauge,
- c) Alternator warning light,
- d) Engine oil pressure warning light,
- e) Odometer and Rev Counter,
- f) Warning systems lights fitted

8. **Colour**

Vehicle and Load body must be painted **WHITE**; the Tenderer is to ensure that this vehicle is colour matched to the existing fleet of vehicles.

9. **Warrantees required**

The Tenderer shall guarantee the vehicle and accessories purchased in respect of performance and defects for a period of at least twelve months from delivery date and this guarantee should include at least TWO (2) free services and shall include travelling, labour and lubricants and filters.

10. Delivery of goods

The delivery of goods must be made within four (4) months from the date of appoint Delivery shall be made to the Dr. J.S. Moroka Local Municipality.

11. Information to be provided with the bid

Sketches, photos and illustrations must accompany the tender documents.

Tenderer's shall clearly indicate whether production of any of the items offered will be stopped or revised during the twelve- (12) month period after the acceptance of tender, if applicable. Tenderer's who fail to supply such details will be held responsible for the replacement of such vehicles and / or equipment.

As the vehicles are to be used on public roads, the following shall be supplied with each vehicle on delivery for registration purposes:

- Change of ownership document (NCO, PART A & C completed),
- (VAT certificate or invoice indicating VAT registration number,
- Delivery note (as well as invoice if applicable).

12. First aid bag

A fully equipped first aid bag that is to be kept in the cab must be included.

13. Draw bar

A heavy duty under run protective bar must be fitted as standard.
A reverse light and backup alarm must be fitted as standard.

14. Fire extinguisher

The fitment of a suitable fire extinguisher to the truck must be included (9kg Dry Powder Type).

15. SERVICE AND MAINTENANCE PLAN

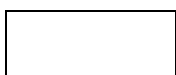
The Service Provider shall provide individual maintenance plans for the Honey Sucker Truck for a 3 Year Period or 120 000 kilometres whichever comes first, at no cost to the receiving Local Municipality or Nkangala District Municipality. The service maintenance to the vehicles shall be undertaken at either 10 000- or 15 000-kilometre intervals.

16. REGISTRATION AND BRANDING OF THE HONEY SUCKER TRUCK

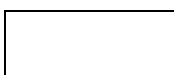
Following the manufacturing of the Honey Sucker Truck according to the prescribed specifications, and delivery to the Dr. J.S. Moroka Local Municipality, the Vehicles shall be branded with colours and logo of the Dr. J.S. Moroka Local Municipality.

The vehicles shall also be registered by Service Provider at the respective Vehicle Licensing Centre, under the name of Dr. J.S. Moroka Local Municipality, after which Roadworthiness Certificates, License discs and Number Plates shall be delivered to NDM. All costs relating to the registration shall be built in to the total tendered amount as approved by NDM and awarded to the Service Provider.

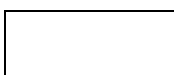
The Honey Sucker Truck shall be branded with Dr. J.S. Moroka Local Municipality's branding and logo.



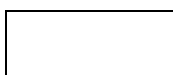

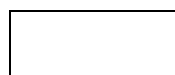

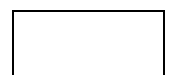

17. TRANSPORTATION AND DELIVERY OF THE HONEY SUCKER TRUCK

Following the manufacturing of the Truck according to the prescribed specifications, the Honey Sucker Truck shall be delivered to Dr. J.S. Moroka Local Municipality. All costs relating to the transporting and delivery of the vehicles to Dr. J.S. Moroka Local Municipality in Siyabuswa shall be built into the total tendered amount as approved by NDM and awarded to the Service Provider.

18. INSURANCE COVER FOR HONEY SUCKER TRUCK

Until such time the vehicles are delivered to Dr. J.S. Moroka Local Municipality, the Service Provider shall be responsible for the insurance cover for the vehicle during its manufacturing and transportation to Dr. J.S. Moroka Local Municipality.
