

# Justice under a tree?

Tlhabane - The Bafokeng Magistrates Court in Tlhabane was abruptly closed on Wednesday, 20 August 2025, after inspectors declared the building unsafe for both staff and the public. The inspection revealed that the structure was in a dire condition, leading to an immediate shutdown. The closure caused major disruptions. Dozens of cases were postponed, leaving detainees to wait longer behind bars while their families continued to shoulder the burden of legal fees

In a scene described as surreal and deeply troubling, court proceedings were reduced to being conducted outside under a tree — only to postpone matters to later dates.

The good news, however, is that the court confirmed it resumed operations on Monday, 1 September 2025. Still, the temporary shutdown highlighted just how fragile access to justice can become when infrastructure is neglected

# **Water Quality** A Key Focus of Magalies Water's Service Excellence

Magalies Water is a well-established water board responsible for operating the Vaalkop Treatment Plant. The treatment plant is equipped with advanced water treatment technologies to purify raw water to potable water standards. Specifically, drinking water produced by Magalies Water from this scheme is measured against the SANS 241 Drinking Water Standard specifications. The water utility implements comprehensive risk assessments supported by tailored incident management protocols and risk-based monitoring programmes to identify problematic parameters timeously, allowing for the immediate implementation of remedial corrective actions to address and mitigate risks. Routine monitoring of water quality is conducted through an ISO/IEC 17025:2017 accredited laboratory, ensuring the reliability of the results produced.

The produced water gets distributed to Moses Kotane and Rustenburg Local Municipalities through distribution networks that connect from the Vaalkop Treatment Plant. Based on risk indices, SANS 241 categorises water quality according to potential health impact, which includes Acute Health 1, Acute Health 2, Chronic Health risk, Operational risk, and Aesthetic risk. The overall performance of the Vaalkop WTW, along with Moses Kotane and Rustenburg Local Municipalities, for the period April 2025 to June 2025 is summarised in Table 1.

Table 1: Water quality profile for the Vaalkop WTW, Moses Kotane, and Rustenburg LM from April 2025 to June 2025.

As summarized in Table 1, it is evident that the water produced and supplied by Magalies Water to Rustenburg and the Moses Kotane Local Municipality meets and exceeds the minimum requirements for health-related indicators, with minimal operational challenges. The water quality is acceptable and suitable for human consumption. The compliance with water quality standards exceeded the SANS 241 targets for all health risk indices that can impact consumer health and water aesthetics. The raw water quality over the last decade has deteriorated drastically, and this could be attributed to upstream catchment activities, which lead to the ingress of contaminants and nutrient enrichment into the Vaalkop Dam. The Vaalkop Dam is highly eutrophic, which has led to algal bloom and water hyacinth coverage of the dam. Magalies Water, along with the Department of Water and Sanitation (DWS) and stakeholders, are evaluating resource management strategies in a quest to protect the catchment

As a countermeasure to poor raw water quality, the water utility has invested in robust technologies, including the addition of advanced technologies such as chlorine dioxide, to ensure water quality compliance while minimizing operational risk. The operational non-compliance, particularly the turbidity non-conformances at both the treatment system and the municipal distribution system, can be attributed to multiple factors, such as aging infrastructure, demand management strategies, and poor raw water quality.

However, through our risk-based water quality monitoring programme and incident management protocol, as well as innovative technological applications at our treatment works, Magalies Water remains committed to supplying drinking water that is fit for human consumption.




