TERMS OF REFERENCE

1. INTRODUCTION

The SADPMR listed as a schedule 3A public entity in terms of the Public Finance Management Act (PFMA). In terms of paragraph 55 of the PFMA, Accounting Authority of the public entity must prepare financial statements for each year in accordance with generally recognised accounting practices as approved by the Accounting Standard Board.

2. OBJECTIVE

The SADPMR require the financial reporting system to be used to prepare financial statements that are compliant with the Generally Recognised Accounting Practice as approved by the Accounting Standard Board. The office of the Chief Financial Officer does not have an in-house system to prepare financial reports to be presented to the Auditor-General, Department of Mineral Resources and National Treasury.

3. SCOPE OF WORK

The system must have the following as a minimum:

- a) The system must be run online with the highest industry security standards
- b) The system must allow unlimited number of users
- c) The initial cost of the system must include the cost of software, installation and setup.
- d) Training and system support must be provided
- e) The system must be able to prepare financial statements with minimal manual intervention especial the cashflow statement.
- f) The system must be able to prepare financial statements and notes that are GRAP compliant and regularly updated with changes in accounting standards
- g) The system must be able to prepare automated financial statement notes that comply with the requirements of GRAP
- h) The system must be able to import the trial balance and budget from Pastel excel
- i) The system must be able to prepare customized financial reports in line with the requirements of SADPMR.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
