### **Quotation for the appointment of a service provider to supply and deliver blesbok to the Rietvlei Nature Reserve within City of Tshwane**

#### **1. INTRODUCTION AND PURPOSE**

The aim of the quotation is to appoint a service provider (game capture company) to supply specific game species, Blesbok, to Rietvlei Nature Reserve within the City of Tshwane.

#### **2. BACKGROUND**

The service provider must supply the City with the animals required. These are mainly prey animals required to sustain the predator population where intervention is needed to sustain food chains (Cheetah Metapopulation Project conducted by the Endangered Wildlife Trust). It is also required to address possible inbreeding situations that are determined by the City's nature conservation staff members.

#### **3. PROJECT SCOPE**

Only game capturing companies must apply for the quotation because they are equipped and can comply with the legislation requirements to supply game. The City of Tshwane acknowledges that game capturing companies buy animals from game farms and nature reserves to sell to other end providers and must cover costs and make a profit for their business.

The prices should be market related and the City will have the right to accept any of the offers or parts of the offer. The City will not be liable for any losses or damages experienced by the service provider during animal delivering operations. The bidder will be responsible for any incorrect killing or injuries that may occur.

The service is required at Rietvlei Nature Reserve.

## 4. DELIVERABLES

The service provider is responsible for the application and acquisition of permits (transportation permit, possession permit and veterinary permit) before the commencement of the capture operation via the Gauteng Department of Agriculture and Rural Development Permits Office, as well as other provincial conservation authorities. Copies of permits for the full quota of animals, as specified in the quotation, should be provided to the relevant nature reserve before the commencement of the capture operation. Permits usually take from 14 to 30 days, depending on application and approval process.

The service provider must provide all the equipment, tools, material, and labour to conduct the operation. The service provider must make provision for transport, crates, and tranquilisers, where necessary.

Further, the operator must adhere to the conditions as outlined below.

### 4.1 CONDITIONS OF THE ANIMAL PROVISION CONTRACT

- The City of Tshwane reserves the right to withhold part or the entire quotation before awarding the contract.
- The contractor must fulfil the entire contract within the specified time frame.
- No accommodation is available on any of the reserves and the successful contractor will need to make his/her own arrangements in this regard.
- It is the responsibility of the service provider to ensure that all legal requirements are met with the delivery of the game and the City of Tshwane will not be held responsible for the lack of permits by the deliverer.
- The responsibility of ownership of the animals is only transferred to the City of Tshwane as soon as the game is delivered to the nature reserve.
- Blesbok sex ratios are determined by the responsible nature conservationist and set as ration of 1 : 4, meaning one (1) male to four (4) females, these totals are provided to the contractor for the application to translocate (permits) blesbok.
- It is expected that the contractor will deliver young and healthy blesbok.
- The City of Tshwane reserves the right not to accept the best financial quotation, but to approve bidders based on competency, professional conduct, and efficient service.
- The contractor must adhere to all South African National Standards regarding the translocation of game and provide satisfactory proof of previous experience in game capture operations with similar species (last five years).

## 5. STAGES OF EVALUATION

This bid will be evaluated in the following five stages:

- Stage 1: Administrative compliance
- Stage 2: Mandatory Requirements
- Stage 3: Preference point system

- Proof of valid registration as a Wildlife Trader at any Provincial Nature Conservation Department; or
- Proof of valid membership to the Wildlife Translocation Association of South Africa.

## 6.2 PREFERENCE POINT SYSTEM

The preferential points to be used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for specific goals
  - Bidders are required to submit supporting documents for their bids to claim the specific goal points.
  - Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.
  - Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

## **8. MARKET ANALYSIS**

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price. If a tenderer confirms that they cannot, the tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market-related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the second-highest points. If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the quotation.
