## **1. INTRODUCTION**

### **Executive overview**

Eskom Grootvlei Power Station requires Site Maintenance Contract for Boiler Feed Pumps, Condensate Extraction Pumps and Main Cooling water pumps and their auxiliary systems

## **2. SUPPORTING CLAUSES**

### **2.1. Purpose**

The purpose of this document is to define the technical criteria to be met by a supplier that seeks to provide the services as clearly specified in the Scope Of work for this contract. It will further state which documents and the standards such documents should meet in order to be considered for technical evaluation scoring.

### **2.2. APPLICABILITY**

This document shall apply to Grootvlei Power Station Site Maintenance Contract for Boiler Feed Pumps, Condensate Extraction Pumps and Main Cooling water pumps and their auxiliary systems which has 8 Stage centrifugal feed water pump, 2.11M NPSH with the speed of 2970 RPM and the impeller 380 MM and 66" VSSI Vertical Installed concrete volute main cooling water pump with the power rating of 1454 kW, full load current of 155Amps at 990 rpm speed with pump head of 18.6m and the flow rate of 375 m<sup>3</sup>/min and horizontal multi-stage condensate extraction pump, quantity of 200 l/s, head of 130m, power of 330,20kW, efficiency of 74% with the speed of 960 RPM installed respectively.

### **2.3. ACCEPTABLE DOCUMENTATION**

All purchase order and contract documents must be a verifiable Eskom issued document which can be issued by any Eskom site with the relevant systems related to this SOW. The document is a valid document even when the work was executed in the past as well as current. These documents will be verified using SAP system for authenticity.

All qualifications must be SAQA approved, and all trade test certificates issued by an approved training authority. Copies of these documents must be certified accordingly otherwise they'll not be considered for evaluation purposes.

All CV's must be detailed with relevant experience clearly specified/stipulated and traceable references included.

## Evaluation Criteria

The evaluation criteria that will be used for scoring the tender documents is as per attached evaluation sheet. The criteria will be available as part of the documentation from Eskom to the Suppliers during the tendering stage.

Evaluation shall be carried out according to the *Evaluation Criteria as provided.*
